# Liu Zhenmin

**Opening Remarks** 

- In his position, Mr. Liu guides UN Secretariat support for the follow-up processes of the 2030 Agenda for Sustainable Development. He oversees the substantive services to many intergovernmental processes, including the High-level Political Forum on Sustainable Development, the annual meetings of the Second and Third Committees of the General Assembly, the meetings of the Economic and Social Council, including its Development Cooperation Forum, and the work of the subsidiary bodies of ECOSOC.
- Mr. Liu also convenes the Executive Committee on Economic and Social Affairs and advises the United Nations Secretary-General on all development-related issues, including climate change, internet governance, and financing for development. In addition, the Secretary-General has designated Mr. Liu is to lead preparations for a number of forthcoming development-focused global conferences, including the Ocean Conference and the Second Global Sustainable Transport Conference.



 Giovanni De Santi is the Director of the Directorate for Sustainable Resources of the Joint Research Centre of the European Commission since September 2017. This Directorate provides independent scientific evidence to support the development, implementation, evaluation and coherence of EU policies, mainly in the areas of agriculture and rural development, development cooperation, environment and climate change, blue growth and fisheries, the bioeconomy, industry and trade.

Launch of Publication

- Giovanni De Santi has been employed at the Joint Research Centre (JRC) since 1985, where he developed his professional expertise by managing projects and groups of experts in the fields of energy, transport, mechanical/nuclear engineering, environmental science and management.
- In 2007, he was nominated as Director at the JRC, initially of the Institute for Energy of the JRC based both in Petten (the Netherlands) and Ispra (Italy). The Institute for Energy became the Institute for Energy and Transport in 2011, and its portfolio consequently expanded to include sustainable transport. In 2016, Giovanni De Santi became Director of the Directorate for Competences.



#### **Global pathways to 2050**

- Reference no explicit policies (NSUS)
- Scenarios of to keep temperature increase by the end of the century below
  - 2.0 degree Celsius (SUS)
  - 1.5 degree Celsius (SUS+)

#### Main messages

- The business-as-usual scenario is unthinkable.
- Complementary measures to avoid an increase in inequality, hunger and malnutrition.
- Also Biodiversity needs specific attention.
- Without integrated policies and international assistance to the less fortunate regions, the pursuit of climate targets could make developing countries slip back on key SDGs.

- Writing a complementary VNR report
  - -Status on Agenda 2030 driving principles e.g. participation, LNOB and the 17 SDGs
  - Civil society contributions to SDGs in Cameroon
  - Recommendations to Government



- Engagement with the Government VNR process
  - CSOs represented in the Government VNR working group
  - Information sharing with Government e.g. Disability report, SDG 4, etc
- > Submission of the complementary report with the Government
  - Full report and summary note
  - Complementary report appended to National VNR report
- Participation in the High Level Political Forum July 2019
  - Civil society panellist in a side event on Education Reform in Cameroon (SDG4)
