


## **Implementing SDG 14** *with the* **Communities of Ocean Action**

Ambassador Peter Thomson UNSG's Special Envoy for the Ocean

Peter Thomson has served as the UN Secretary-General's Special Envoy for the Ocean since September 2017. In this role he leads UN advocacy and efforts for the implementation of SDG14, including the many positive outcomes of the 2017 UN Ocean Conference.

Ambassador Thomson served as President of the 71st session of the UN General Assembly. 2016–2017. Ambassador Thomson was Fiji's Permanent representative to the UN from 2010 to 2016.

### The forthcoming Ocean Conference, co-hosted by the Governments of Kenya and Portugal,

will come at a critical time as the world is strengthening its efforts to mobilize, create and drive solutions to realize the 17 Sustainable Development Goals by 2030 in the context of an ongoing global pandemic. How we respond to COVID-19 beyond the immediate and necessary recovery of health and livelihoods will likely determine not only whether we will reach SDG 14, but also how sustainable the world of tomorrow will be.

The high-level United Nations Conference to Support the Implementation of Sustainable Development Goal 14: Conserve and sustainably use the oceans, seas and marine resources for sustainable development: The 2017 Ocean Conference co-hosted by Fiji and Sweden paved the way for action oriented, science based innovative solutions aimed at reversing the decline in the health of our ocean for people, planet and prosperity.

At the 2017 conference, approximately 1,400 voluntary commitments (VC) for concrete action to advance implementation of SDG 14 were made by Member States, the UN system, and an array of stakeholders including civil society, the private sector and academia. To date, over 1,600 VCs are registered online and the registry of voluntary commitments remain open. These commitments were one of the major outcomes of the conference and marked a global breakthrough on the path to sustainable management and conservation of our oceans, seas and marine resources.

To follow-up on the implementation of these voluntary commitments as well as to catalyse and generate new ones, the UN launched nine thematic multistakeholder Communities of Ocean Action (COA) of which are closely aligned with the targets of SDG14.

Recently, an online survey on the implementation of VCs published on the Ocean Conference Registry was carried out to get an update on the achievements and challenges as well as to receive suggestions on its implementation. The assessment of the impact of these commitments based on the survey and other available information, concluded that the VCs have collectively furthered the attainment of SDG 14.

Nevertheless, various challenges to their implementation have been reported such as, the lack of resources, funding, technical expertise, partner cooperation as well as political environment. Furthermore, the unprecedented COVID-19 pandemic that broke out last year has further exacerbated challenges in the implementation of the VCs. This webinar will take a look at the status of implementation of the VCs as well as the impacts of the COVID- 19.









Before serving as Permanent Representative of Portugal to the United Nations, Ambassador Francisco Duarte Lopes was the Director-General for Foreign Policy, Political Director, Ministry of Foreign Affairs of Portugal, 2014 to 2017. He has served as Director-General for European Affairs, 2012 to 2014 and was Diplomatic Advisor to the Prime Minister of Portugal from 2009 to 2011.

He has been designated as the Secretary-General of the UN Ocean Conference to be held in Lisbon in 2021, in which role USG Liu serves as the focal point within the UN Secretariat for the organisation of the conference.

Miguel de Serpa Soares was appointed Under-Secretary-General for Legal Affairs and United Nations Legal Counsel in 2013. USG de Serpa Soares has been designated as the Special Adviser on Ocean and legal matters to the Co-Presidents of the UN Ocean Conference.



**Takehiro Nakamura** Chief of Unit UNEP



On this position, he has been engaged in addressing and reversing degradation of marine and coastal ecosystems through the application of ecosystem approaches, integrated coastal zone management, blue carbon and other ecosystem-specific management approaches (particularly mangroves, seagrass beds and coral reefs). Recently he focusses on the environmental aspects of sustainable development of marine and coastal areas to achieving Sustainable Development Goals relevant to the marine and coastal ecosystems. He received a Ph.D. in Global Environmental Studies from Kyoto University.

Ambassador Anna Karin Eneström is the Permanent Representative of Sweden to the United Nations since December 2019. Ambassador Eneström is a Swedish diplomat with extensive experience from several top positions worldwide. She has served as the Representative to the Political and Security Committee at the Permanent Representation of Sweden to the European Union in Brussels, she was the Special Envoy to Afghanistan and Pakistan, and the Swedish Ambassador to Pakistan and Afghanistan.



Ambassador Satyendra Prasad is the Permanent Representative of Fiji to the United Nations since 2018. Before that, Mr. Prasad was the Chief Executive Officer of the Papua New Guinea Governance Facility. Before that, he served as Senior Governance Adviser at the World Bank between 2009 and 2016, Governance Adviser at the United Kingdom's Department for International Development from 2003 to 2009, and Commissioner of Fiji's Public Service Commission from 1998 until 2000.
