



# SDG GOOD PRACTICES, SUCCESS STORIES AND LESSONS LEARNED IN THE IMPLEMENTATION OF THE 2030 AGENDA

Second Open Call: Towards the Decade of Action to Deliver the Sustainable Development Goals



#### INTRODUCTION

The United Nations Department of Economic and Social Affairs (UNDESA), through its Division for Sustainable Development Goals (DSDG), launched a Second Open Call for good practices, success stories, and lessons learned in the implementation of the 2030 Agenda for Sustainable Development and its 17 Sustainable Development Goals (SDGs). The second open call was conducted from December 2020 to March 2021 aiming to highlight examples of good practices, including those that could be replicated or scaled up by others across the globe.

Submissions show inspiring breakthroughs, lessons learned, and success stories related to the implementation and follow-up of the SDGs at all levels (global, regional, national, and sub-national). Several submissions address steps taken to support recovery from the COVID-19 pandemic.

More than 700 submissions were received for the Second Open Call for SDG Good Practices. More than 460 were approved by the Inter-Agency review team.



Global initiatives comprised 15% of approved submissions. Submissions were also received from Asia and the Pacific (26%), Europe (18%), Africa (16%), Latin America and the Caribbean (16%), Global (15%), West Asia (6%), and North America (3%). Proposals came from sectors including United Nations/ multilateral body (21%), non-






governmental organizations (24%), private sector (15%), governments (12%), local governments (7%), intergovernmental organizations (7%), and others.

#### BACKGROUND

A First Open Call for SDG Good Practices was conducted from November 2018 to February 2019 and a <u>digital publication</u> was published by UN DESA based on the results. Governments, UN entities, international and regional organizations, and stakeholders from all relevant sectors submitted proposals which were reviewed by an Inter-Agency Team of experts representing 24 United Nations Entities.

#### HIGHLIGHTED PRACTICES

The Second Open Call for SDG Good Practices pooled several outstanding submissions, including a few highlighted at the United Nations High-Level Political Forum session of 2021. #### European Commission | Global focus

#### Partnership for Action on Green Economy | Global focus

PAGE unites five United Nations agencies — UNEP, the ILO, UNDP, UNIDO and UNITAR — to provide integrated and holistic support to countries on eradicating poverty, increasing jobs and social equity, strengthening livelihoods, and environmental stewardship and sustaining growth, ensuring coherence and avoiding duplication of efforts. Launched in 2013 following the Rio+20 Conference, PAGE currently supports 20 countries, working with national and regional governments to build inclusive, green economy transitions to support concrete action and accelerate action on SDGs and the 2030 Agenda.

### The Egyptian Ministry of Planning and Economic Development | Africa, Egypt

The Government of Egypt (GOE) and the World Bank (WB) launched the Upper Egypt Local Development Program (UELDP) in 2017. UELDP worked on improving basic service offerings and invigorating local economic development at the local level while observing the social & environmental safeguards through national and international partnerships. It introduced national policy reforms that demonstrate Egypt's commitment to inclusive & sustainable development embodied in poverty reduction, improving people's lives and reducing disparities.

#### <u>City of Los Angeles | North America, United States</u>

Los Angeles pioneered two open-source tools for SDG action at the local level: the Open Source SDG Data Reporting Platform (Open SDG) and the SDG Activities Index. While Open SDG was developed for national statistics, L.A. is the first city to adapt it for sub-national reporting. The SDG Activities Index is a searchable and exportable crowd-sourced encyclopedia of organizations advancing the SDGs in L.A. designed to build local shared capacity for the SDGs. Both tools have wikis, and their code can be reused by other organizations to advance the SDGs in their communities.

From 2010 until today, 2,500+ toilets have been installed in over 25 countries across 5 continents, including Jordan, Chile, and Sweden.

# Young Forestry Entrepreneur (JEF) | Latin America and the Caribbean

Promoting decent work for the young population and designing strategies for their insertion in labor markets remain a challenge in Latin America. Therefore, in 2013, the Young Forestry Entrepreneur Contest (JEF) was created to add to the technical knowledge of forestry students' skills in social and economic issues through an entrepreneurial approach to generate innovative ideas that positively impact forests. 8,677 students have been trained, and 625 projects from 13 countries have been received.

#### African Clean Initiative | Africa, Nigeria

The Recyclespay Educational Project is a Plastic-For-Tuition project with the goal of paying the tuition fees of over 10,000 vulnerable students by the year 2030. The project integrates environmental, economic, and social indicators by reaching communities without access to proper waste management systems, establishing a sustainable system where plastic waste and other waste forms are recovered from the source while empowering parents, schools, and children.
