Ladies and Gentlemen

It is my great honour to be part of this important workshop on the Rollout of the National Development Strategy 1 -Integrating the 2030 Agenda. As we are in our first year of implementing the National Development Strategy 1 (NDS 1) which coincided with the commencement of the Decade of Action and Delivery as declared by the United Nations Secretary General, it is vital that we reflect on the effectiveness of processes and institutions that are driving the implementation of these development agendas at global, regional and local levels hence the convening of this workshop.

bold policy interventions, coupled with visionary leadership which strengthens the coordination and attainment of SDGs which we aim to achieve by implementing the National Development Strategy 1.

The developmental trajectory that our country has embarked on through the implementation of the Vision 2030 and the NDS 1 if supported by adequate resource allocation and commitment at all levels among stakeholders will surely enable us to attain most of the SDGs by the year 2030. We are aware that some acceleration actions should be prioritised so that we maintain our momentum and direction towards the achievement of the 2030 Agenda. Ladies and gentlemen, through the Vision 2030 and National Development Strategy 1(NDS 1) which are not just bold statements but a Call and Demand for Action from every stakeholder we will win together. The greatest key to achieve SDGs can only be our concerted efforts toward the attainment of these global goals as outlined by the principle of leaving no one behind. As the 2030 Agenda is about **People**,

Planet, Prosperity, Peace and Partnerships, focusing on these five Ps will enable us to attain a well-balanced growth as living standards are enhanced in a more sustainable manner while caring for the environment as we preserve our only planet earth.

Ladies and gentlemen,

The 2030 Agenda has been incorporated and internalised into the Vision 2030 and the National Development Strategy **1(NDS 1)** that were established on broad citizenry participation aimed at ensuring that no one is left behind in our development Citizenry participation as base and anchor of agenda. development planning has facilitated increased budgetary support for investment initiatives and expenditure in areas such as social protection, agriculture, infrastructure, health, and education, to name just a few. The rolling out of the NDS 1 has gathered serious traction and speed as evidenced by translation of the national development plan into official languages including braille and the effective dissemination that has covered those

furthest left behind such as rural communities as the country is implementing the **Whole of Government** and **Whole of Society** approach in national development.

Ladies and gentlemen,

Current public policy models are certainly a reflection of a shift from traditional thinking to focus more on issues of accelerated economic growth, sustainability, value addition and climate change among other factors. Additionally, enough confirmation of bold and visionary leadership is evidenced in public sector transformation that is manifest in the metamorphosing of structures and processes that support development from grassroots level. The devolution agenda will go a long way in improving the livelihoods of communities as they will benefit from local resources thereby improving standards of living for all and accelerating the attainment of SDGs.
