Why SDGs for Zimbabwe?



- SDGs are at the heart of the 2030 Agenda and Vision 2030 in Zimbabwe.
- The 17 SDGs are the means of tracking (results framework) for the 2030 Agenda.
- Failure to monitor and measure performance on the 17 SDGs, means progress made towards the 2030 Agenda cannot be tracked.

Pan African Vision of *An integrated, prosperous and peaceful Africa, driven by its own citizens, representing a dynamic force in the international arena*





Why an SDG M&E Framework?

- Tangibly trace and demonstrate Zimbabwe's progress in attaining the SDGs.
- Demonstrate how line Ministries are contributing the implementation of the 2030 Agenda.
- Tangibly illustrate the contribution of the National Development Plan and Vision 2030 to the 2030 Agenda.
- Enhance the capacity of M&E personnel in line Ministries to mainstream the 2030 Agenda when developing their monitoring and evaluation plans.



Progress to Date

- 2016: SDG **baselines** were set and institutional structures put in place.
- 2018: **Institutional structures** were updated in line with the context – clusters introduced
- 2019: A comprehensive **SDG M&E Framework** was developed. The framework is a living document that is updated regularly.
- **The SDGs M&E Framework** was used in producing the **2020 SDG progress report**.
- The **SDG M&E Framework** was updated in **2021** and a review report was produced.
- 2021 **Voluntary National Review** presented at the HLPF.
- Both the Monitoring Template and the Evaluation Templates were populated in line with the revised **National Monitoring and Evaluation Policy for Zimbabwe**.
