Information note

Introduction

Further to <u>General Assembly resolution 75/290A</u> on the strengthening of the Economic and Social Council (ECOSOC), the 2022 ECOSOC Partnership Forum will be held on **2 February**, back-to-back with the Council's <u>new coordination segment on **3-4 February**</u>.

The Partnership Forum will feature an exchange of new ideas, expectations and priorities for the work ahead for the Council cycle and the HLPF held under the auspices of the Council. The Partnership Forum will also discuss forward-looking actions by countries and all relevant stakeholders as well as innovative partnerships that can mobilize commitments and actions to advance the 2030 Agenda.

Because of its timing in early February, the 2022 Partnership Forum will be a key opportunity to galvanize Member States and all other key stakeholders, including the UN system, international financial institutions, as well as international organizations, parliamentarians, local governments, NGOs, the private sector, civil society, scientists, academia, women, youth and other stakeholders, early on in the ECOSOC cycle.

Theme

The 2022 ECOSOC Partnership Forum will be held under the main theme of the ECOSOC and the high-level political forum on sustainable development (HLPF) *"Building back better from the coronavirus disease (COVID-19) while advancing the full implementation of the 2030 Agenda for Sustainable Development"*.

Format

Due to the ongoing surge in COVID-19 cases in New York City, the Forum (including all official sessions and side events) will be fully virtual. The Forum will be a one-day event (2 February 2022), chaired by the ECOSOC President, featuring an opening and a closing session, two plenary sessions, a number of informal events including spotlight sessions, two partnership exchanges, as well as side events.

The opening and closing sessions and the plenary sessions will be held on Zoom, and live streamed via UN Webcast (webty.un.org) and on the Whova online event platform.

There is no pre-established list of speakers for the plenary sessions. In order to request the floor during the plenary sessions (9.30-10:50 a.m. and 5-5.50 p.m.), participants will need to inscribe through an online speaker form which will be posted by the Secretariat in the Zoom chat box. The form will be enabled at the start of the meeting and no requests can be made before that time. Given the limited time available, interventions should be limited to <u>3 minutes or less</u>. The time limit will be strictly implemented, including through the muting of microphones once the time limit is reached.

Written copies of all statements delivered during the plenary sessions should be sent to <u>estatements@un.org</u> at least two hours in advance of delivery in order to ensure proper interpretation. Interpretation for statements not sent in advance may be impacted or suspended given the additional difficulties related to remote simultaneous interpretation. The subject line of the email should clearly identify the date and time of the meeting at which the intervention will be delivered.
