# FOR THE IMPLEMENTATION OF THE SMART SPECIALISATION STRATEGY IN THE REPUBLIC OF SERBIA

FOR THE PERIOD 2021-2027

Pursuant to Article 38, paragraph 1 of the Law on the Planning System of the Republic of Serbia ("Official Gazette of the Republic of Serbia", No. 30/18)

the Government hereby adopts



## INTRODUCTION

The Government adopted the Smart Specialisation Strategy in the Republic of Serbia for the period 2020–2027 (hereinafter: Strategy) at its session held on 27 February 2020. Adoption of the Strategy ended a three-year long period of its elaboration, launched in 2017 by the Ministry of Education, Science and Technological Development (hereinafter: MoESTD) and the Republic Public Policy Secretariat. With the support of the Joint Research Centre (JRC) and through close monitoring of the methodological framework for the elaboration of the Strategy, the MoESTD and other partners worked thoroughly to identify the needs of all stakeholders. As the result of conducted analyses and the consultative process – EDP¹, priority areas, general goal, specific objectives and associated measures of the Strategy have been identified.

Proper implementation of measures and hence achievement of the Strategy goals will largely depend on the Action Plan for the period 2021–2022 for the implementation of the Smart Specialisation Strategy in the Republic of Serbia for the period 2020–2027 (hereinafter: Action Plan) and its contents. For this reason, the development of the Action Plan is one of the key priorities of the Government and of the MoESTD. Shortly after the adoption of the Strategy, a crisis caused by the global COVID-19 pandemic started and significantly hindered and slowed down the process of drafting the Action Plan. In light of the new challenge, MoESTD representatives decided to avail themselves of the longer time it took to draft the Action Plan to make all necessary changes that will enable all actors in the priority areas to better respond to the new reality.

The Action Plan, as a public policy document that is an integral part of the Strategy, contains all the measures and activities necessary to achieve the general and specific goals of the Strategy. The Action Plan has been developed for the period 2021–2022 to enable a timely revision of the goals and identified measures, in continuous dialogue with all stakeholders and institutions implementing the measures. Approach taken so far has made the Republic of Serbia an example of good practice in the Western Balkans as regards the ways to implement the smart specialization framework. Continuing along the same path with a realistic and comprehensive Action Plan is the goal of all parties involved.



### Implementation and relevant events in the period following the adoption of the Strategy until the completion of the Action Plan

Given the time period that elapsed from the adoption of the Strategy to the finalization of the Action Plan, the Action Plan contains certain adjustments in relation to the Package of Measures defined in the Strategy, which are to some extent a reflection of the changed perspective on the development of science and economy areas that are in the focus of the Strategy after the outbreak of the pandemics, as well as events relevant to meeting the Strategy goals that have occurred in the meantime.

As a result of harmonization with the recommendations and comments on the text of the Strategy by the Joint Research Centre of the European Commission, the Action Plan contains a more comprehensive set of measures and indicators, implying adjustment and improvement in relation to the measures and indicators contained in the Strategy. In addition to the expert support received from the Joint Research Centre of the European Commission, the goals, measures and indicators of the Action Plan are also harmonized with the relevant institutions in the Republic of Serbia responsible for monitoring and oversight of the Action Plan implementation.

The structure of the Action Plan follows one general goal and five specific objectives set out in the Strategy, which have largely remained unchanged, except for the specific objective 2, which is further supplemented with the intention to indicate that future economic development will be based on innovation, in addition to previously emphasized research and development and cooperation among the quadruple helix participants.

The measure implying an amendment to the Rulebook on the procedure, manner of evaluation and quantitative presentation of scientific research results of researchers was added within the specific objective 1, as it was concluded that the implementation of the amendment to the Rulebook will significantly contribute to research excellence and focusing of scientific activities to Strategy priorities.

Measures within the specific objective 2 have been further improved through reallocation of existing measures within other objectives or through the definition of additional ones, in cooperation with the relevant ministries in charge of implementing the Strategy. New measures have been added, the implementation of which will contribute to greater investment of the business sector in R&D as well as more intensive use of public research infrastructure by private entities in priority areas. In addition, additional measures were defined in cooperation with the Ministry of Agriculture, Forestry and Water Management (hereinafter: MoAFW), and relate to investments in physical assets concerning processing and marketing of agricultural and fishery products (IPARD measure 3) and farm diversification and business development (IPARD measure 7).

Measures under specific objectives 3 and 4 have been further improved and supplemented. Within objective 3, three new measures are defined which foresee the development of models for internships in companies within the programmes of basic and higher levels of studies, as well as the adoption of a rulebook on the procedure for submitting an application and for evaluation of technical solutions and defining the legal framework for the implementation of industrial doctorates. In addition to the measure that implies the analysis of administrative procedures in terms of its relevance for the development of priority areas of the Strategy, objective 4 is supplemented by measures to optimize and digitize identified procedures in the areas of the Strategy and improve the Register of administrative procedures according to end user needs, thus further enhancing the set of measures within this objective.

Objective 5 is supplemented with three measures that will significantly contribute to greater internationalization of the economy through its inclusion in regional and global value chains. Additional measures will be implemented in cooperation with the Ministry of Economy, and include the following: Identification and encouragement of export-oriented sectors of industry of higher stages of processing; Support programme for internationalization of industrial economic entities and Support programme for industrial economic entities for entering the supply chains of multinational companies. These measures are also contained in the Action Plan of the Industrial Policy Strategy of the Republic of Serbia from 2021 to 2030, representing an important aspect of linking and synergy between the two strategies. The added measures will significantly contribute to the realization of objective 5.

The indicators of effects at the level of the general goal, the indicators of outcomes at the level of specific objectives and the output indicators at the level of measures have been significantly improved in relation to the indicators defined in the Strategy. The new indicators reflect the outcome of the

consultation process carried out with the consultants and institutions in charge of implementing the measures. An improved set of indicators defined in the Action Plan will contribute to a quality process of monitoring the degree of achievement of general and specific goals of the Strategy.

In the meantime, several measures envisaged by the Strategy have been implemented or their implementation has started.

Policy measure 2.1: In 2020, the Innovation Fund carried out the call for the award of innovation vouchers. Out of a total of 118 approved innovation vouchers, worth 60 million dinars, 72% were in the priority areas determined by the Smart Specialization Strategy.

Policy measures 2.3 and 2.6: Innovation Fund's public call for the Early Development (Mini Grants) Programme and the Innovation Co-financing (Matching Grants) Programme announced in 2020 was harmonized with the Smart Specialization Strategy in the Republic of Serbia. The manuals for these programs define that at least 50% of the available funds for the public call will be allocated to projects in priority areas, if sufficient quality projects are available. The budget allocated for this public call was EUR 5.3 million from the budget of the Republic of Serbia. The total number of applications was 322, of which 253 for the Mini Grants Programme and 69 for the Matching Grants Programme. After the first phase of project evaluation, the Expert Commission made a decision to shortlist a total of 66 projects, of which 46 for the Mini Grants Programme and 20 for the Matching Grants Programme. In December 2020, all shortlisted projects were presented directly to the members of the Expert Commission. After the presentation of the projects, the Expert Commission made a decision on financing 21 projects within the Mini Grants Programme and 14 projects within the Matching Grants Programme. Out of a total of 35 projects, 34 were from the priority areas defined by the Smart Specialization Strategy.

Policy measure 2.8: In coordination with the MoESTD and the Innovation Fund, USAID announced the first public call and allocated funds in the amount of 4 million dinars to companies that will, in cooperation with the IT sector, improve their business and product and packaging design.

Policy measure 3.2: In 2020, MoESTD issued a call, selected and approved for implementation 41 projects for the improvement and development of curricula in higher education institutions with a focus on innovating existing study programs to follow the needs of the labour market, developing entrepreneurial skills of students and improving cooperation between higher education institutions and business sector and other interested actors in the local community, increasing the use of information technology in teaching and learning, etc. The total budget for the support of these projects in 2020 amounted to 13 million dinars, and an additional 17 million dinars have been allocated for 2021.

THE SMART SPECIALIZATION STRATEGY

Policy measure 3.4: In 2020, MoAFW, together with USAID and UNDP, with the total amount of nearly one million dinars supported the national student competition which aims to encourage student innovation and creativity in the production of new food products with added value, with additional focus on environmental protection. The winner of the national competition represented our country at the European competition.

Policy measure 3.5: MoESTD announced a public call, made a selection and financially supported two new study programmes of master's academic studies aimed at creative industries, i.e. connecting art and information technologies, in the total amount of 11 million dinars. Projects of the University of Arts in Belgrade and the Faculty of Mathematics of the University of Belgrade "Art and Design of Video Games" and the University of Kragujevac "Development of Computer Games" were supported.

In addition, during 2020, MoESTD announced a public competition, selected and approved for financing four study programmess of master's academic studies in the field of artificial intelligence, i.e. machine learning "Artificial Intelligence and Machine Learning" in the total amount of 12 million dinars. Projects of the University of Novi Sad (Faculty of Engineering Sciences and Faculty of Sciences), the University of Niš (Faculty Sciences) and the University of Kragujevac were supported.



## Contribution of the Strategy to sustainable development goals

Parallel with the activities of creating the Strategy and the Action Plan, MoESTD recognized the importance of the United Nations Global Programme for creating a Roadmap in the field of science, technology and innovation in order to achieve the Sustainable Development Goals. The Republic of Serbia is one of the 5 countries in the world that participates in this pilot programme. During the stakeholder consultation process, it was concluded that all priority areas of the Strategy have the potential to address the identified global challenges and to contribute to the sustainable development goals.

The "Food for Future" priority area of the Strategy and especially its sub-area "Sustainable Food Production Chain" directly contributes to the second Sustainable Development Goal "World without Hunger". Specific internal capacities to contribute to this goal exist in machines for the agricultural and food industry as well as in improved production processes and new food products. In addition to its direct contribution, the Food for Future area has the potential to create positive externalities on poverty and inequality (goals 1 and 10), better health (goal 3) and sustainable development research (goals 6, 11, 12, 13, 14, 15).

Information and communication technologies (ICTs) have a horizontal contribution to the development of industry, innovation and infrastructure (goal 9) and employment increase (goal 8). Through adequate education, training and employment policies, ICTs contribute to increasing employment opportunities

and thus address the challenges of poverty (goal 1), inequality (goal 10) and gender equality (goal 5). Through a significant role in the development of medical devices, e-health and digital health, ICTs provide great opportunities and contribute to general health and well-being (goal 3). Similarly, ICTs create opportunities for the development and availability of renewable energy (goal 7) and sustainable cities (goal 11), especially in the domains of energy efficiency, smart grids, smart cities and sustainable and efficient transportation.

Creative industries have two direct links to the Sustainable Development Goals: sub-areas: "Creative audio-visual production" and "Video games and interactive media" have an important contribution to quality education (goal 4) in the field of digital education. The "Smart Packaging" sub-area directly contributes to goal 12 – Responsible Consumption and Production. In addition, similarly to ICT, it can make an indirect contribution to goals 1, 5, 8, 9 and 10 through its horizontal impact on design, creativity and entrepreneurship.

The area "Future Machines and Manufacturing Systems" has a horizontal impact on the development of industry, innovation and infrastructure (goal 9) and employment increase (goal 8). Vertically, it contributes to the creation of new products and innovations in production processes in industries that contribute to goals 2, 11 and 12.

Energy efficient and eco-smart solutions directly contribute to achieving the goal of affordable and renewable energy (goal 7). Energy efficient and eco-smart solutions have an indirect positive impact on most social and environmental goals (goals 9, 13 and 15). Key enabling technologies play an important role in achieving goals 2, 3, 6, 7, 9, 11, 12 and 13.

As a summary of these information, Table 1 shows the impact of the Strategy's priority areas on sustainable development goals defined by the United Nations. Depending on the intensity of the contribution, the impact of priority areas is defined as direct and indirect.

## Impact of the COVID-19 crisis on the Strategy implementation

The year 2020 was marked by a pandemic of SARS-CoV2 virus, which fully affected all segments of society in an extremely short period of time. Therefore, it was necessary to launch urgent activities in order to mitigate and channel the health and economic consequences of this condition in the best possible way. For all economies, including the Republic of Serbia, it is necessary to address challenges continuously in order to enable the fastest recovery in the best possible way when conditions allow.

In light of the pace of events related to the pandemic, it is expected that during 2021, which will be marked by mass vaccination of the population and other activities in the fight against the pandemic, significant positive effects on the micro- and macroeconomic environment will be achieved locally and globally. All four helix chains are affected in a very specific way by pandemic events, so it is necessary to communicate with stakeholders through EDP workshops in order to, among other things, analyse the following:

a) impact of the pandemic on various spheres of the economy and society

- operation of businesses;
- new models implemented in education;
- science and innovations;
- adjustment of the public sector to new circumstances;
- civil sector function;


b) pandemic in 2021 and beyond

• application of previous experiences, including innovative solutions, to reduce losses, adjust and improve the quality of work in the private, academic, public and civil sector.

Given the complexity of the situation in which the global market and humanity find themselves, it is extremely important to find effective solutions, including innovative approaches, enabling the participants of the quadruple helix to respond to the complex challenges.

The industrial sector, including the IT sector, practically overnight refocused part of its activities on products and services necessary in the health sector. Science has turned to the search for and development of new testing methods, the development of vaccines and medicines. Innovative companies are undertaking to search for solutions to burning problems. The analysis of the speed and depth with which the pandemic took over the global economy, affecting the economy of the Republic of Serbia too, should provide answers to the expected depth of recession and speed and models of economic recovery, including interventions of policy makers in the years to come.





The Action Plan is a public policy document of the highest level of detail, which elaborates the Strategy, in order to manage the pace of the implementation of public policy measures that contribute to the achievement of its general and specific goals. Proper monitoring of the Action Plan and its elements will ensure a fully inclusive process that will guarantee the continuous participation of all stakeholders.

The Action Plan is revised as necessary, in line with the results of implementation monitoring and the results of the ex-post analysis of public policy effects. A formal obligation of the MoESTSD set forth by the Law on the Planning System ("Official Gazette of the RS", No. 30/18) includes reporting to the Government on the results of the implementation of the Action Plan on an annual basis, as well as the final report after the period for the implementation of the public policy document expires.

To enable a transparent and sustainable process, MoESTD has developed an operational plan that will focus on sustainable dialogue through the continuation of EDP workshops. EDP actors will participate in amending or revising the Strategy measures that do not produce adequate results and will help with their expertise and experience in defining all future measures and goals in the next iteration of the Action Plan that will most likely be developed in 2023. EDP workshops are planned to be held at least twice a year in each priority area, with room for increasing the annual number of workshops. Since all major gatherings have been suspended due to the current epidemiological situation in the country, in 2021, the MoESTD will enable EDP workshops to be held online.

In order to maintain the pace of these activities, MoESTD has developed a schematic overview of monitoring and evaluation activities (Table 2. Timeframe of monitoring and evaluation activities), covering the timeframe of the Action Plan.

As can be seen in the table above, the timing of mandatory EDP workshops and meetings of the Strategy Implementation Working Group will be coordinated with the timing of reporting on the implementation results. The reason for this coordinated timing is to enable all actors and the general public to gain timely insight into all implementation results.

In addition, the Strategy Implementation Working Group will be an important link between the implementation, monitoring and the wider community participating in the EDP. This group will consist of representatives of all bodies in charge of implementing the measures in the Strategy, as well as members of the new internal unit within the MoESTD, established by the SAIGE Project, which is in charge of monitoring the implementation of the Strategy. MoESTD will also include EDP coordinators of each priority area in the work of this group. In this way, the voice of all actors who participated in the development of the Strategy and who will continue to participate in all future activities related to the EDP will be directly ensured. Meetings of the working group are planned to be held quarterly, leaving room to increase this frequency as needed.

External evaluation will be organized after the end of each Action Plan cycle, meaning that the first external Strategy implementation evaluation report will be due in 2023. MoESTD understands the need for the evaluation to be impartial and the financing of external experts who will perform the evaluation will be provided through the World Bank's SAIGE Project. As with the implementation results reports, the timing of mandatory EDP workshops and meetings of the Strategy Implementation Working Group will be coordinated with the timing of the external evaluation, to enable all actors to participate with their inputs and to further ensure transparency of the entire evaluation process.



The Action Plan for the implementation of the Smart Specialization Strategy in the Republic of Serbia for the period 2021–2022 covers the period from 2021 to 2022, and the funds are or will be provided from the budget of the Republic of Serbia and from donor funds. Activities in the Action Plan are coordinated with the activities of donors (EU, World Bank, USAID, UNDP), so that donor funds are included in its implementation.

In addition to MoESTD, the key actors for the implementation of activities within the implementation of measures include the Innovation Fund – IF, the Science Fund of the Republic of Serbia – Science Fund of RS, Centre for the Promotion of Science – CPS, Republic Public Policy Secretariat – RPPS, Ministry of Economy, Development Agency of Serbia – DAS, Ministry of Culture and Information, Office for Information Technologies and e-Government – OITEG, Ministry of Agriculture, Forestry and Water Management – MoAFW, Ministry of Trade, Tourism and Telecommunications – MTTT, Serbian Chamber of Commerce and Industry – CCIS and Ministry of Finance.

Individual measures and activities, with estimated funds for their implementation, which contribute to the achievement of specific goals defined by the Action Plan, are presented in detail in tabular form within the Action Plan itself.

For the achievement of specific objective1: Focusing scientific activity on 4S priorities, within Heading 26 – MoESTD, funds will be allocated within the following appropriations:

- Programme 0007 (Heading 26) Funds are allocated within the existing budget regular allocations of MoESTD, no special funding is required, the measure refers to the monitoring of indicators;
- Programme 0006 (Heading 26) Support to the operation of the Centre for the Promotion of Science. Funds are allocated within the existing budget of the Centre for the Promotion of Science;
- IPA 2019 Programme (Heading 26) Financial Agreement between the European Commission, on behalf of the European Union, on the one hand, and the Republic of Serbia, represented by the Government, on the other hand, regarding the IPA Action Programme for the Republic of Serbia for the year 2019. Funds will be distributed by the Law on the Budget of the Republic of Serbia for the year 2022;
- Programme 0013 (Heading 26) Support to the operation of the Science Fund of the RS. Funds are allocated within the existing budget of the Science Fund.

For the achievement of specific objective 2: Economic development supported through innovation, research and development and cooperation among the participants of the quadruple helix, within Heading 26 – MoAFW, within Heading 21 – Ministry of Economy, within Heading 24 – MoAFW, within

Heading 38 – Republic Public Policy Secretariat and within Heading 29 – Ministry of Culture and Information, funds will be allocated within the following appropriations:

- Programme 0005 (Heading 26) Support to the operation of the IF. Funds are allocated within the existing IF budget;
- Programme 4004 (Heading 26) IPA 2018 Competitiveness, Direct IF grant. Funds will be allocated within the existing budget to 4S priorities. The projected funds concerning the IPA 18 programme activity refer to the total estimated contractually committed funds and are related to the proposed indicators for this measure;
- Programme 4011 (Heading 26) World Bank's SAIGE Project, Loan Agreement Serbia Accelerating Innovation and Growth Entrepreneurship Project MoESTD and IF components. Funds have been allocated and the implementation of activities has begun;
- Programme 4005 (Heading 24) IPARD measure: Technical assistance. Incorporation of smart specialization priorities into the IPARD programme for the Republic of Serbia for the programming period from 2022. Funds are allocated within the existing budget;
- Programme 7047 (Heading 38) Competitiveness and Jobs (C&J) Project MoESTD components. Funds are allocated within the existing budget;
- (Heading 29) Funds are allocated within the existing budget;
- (Heading 21) No funds needed.

For the achievement of specific objective 3: Education focussed on innovation and entrepreneurship, within Heading 26 – MoESTD and within Heading 24 – MoAFW funds will be allocated within the following appropriations:

- Programme 0001 (Heading 24) Support to the realization of general interest in scientific and research activity. No funds have been allocated, the measure is awareness-raising and educational:
- Programme 0014 (Heading 26) Support to higher education;
- Programme (Heading 26) Support for the implementation of master studies at universities. Funds are allocated within the existing budget;
- Programme 4011 (Heading 26) World Bank's SAIGE Project, Loan Agreement Serbia Accelerating Innovation and Growth Entrepreneurship Project MoESTD component. Funds have been allocated.

For the achievement of specific objective 4: Improved business conditions through optimization and digitalization of procedures, within Heading 26 – MoESTD, within Heading 21 – Ministry of Economy, within Heading 38 – RPPS and within Heading 3.24 – OITEG, funds will be allocated within the following appropriations:

- Programme 0001 (Heading 3.24) Development of IT and e-government systems. Funds are allocated within the existing budget;
- IPA 2019 Programme Financial Agreement between the European Commission, on behalf of the European Union, on the one hand, and the Republic of Serbia, represented by the Government, on the other hand, regarding the IPA Action Programme for the Republic of Serbia for the year 2019. Funds will be distributed by the Law on the Budget of the Republic of Serbia for the year 2022;
- Programme 7047 (Heading 38) Competitiveness and Jobs (C&J) Project MoESTD components. Funds are allocated within the existing budget;
- Programme 4011 (Heading 26) World Bank's SAIGE Project, Loan Agreement Serbia Accelerating Innovation and Growth Entrepreneurship Project MoESTD component. Funds are allocated within the existing budget.

For the achievement of specific objective 5: Internationalization of the economy through inclusion in regional and global value chains in 4S areas, within Heading 26 – MoESTD, within Heading 17 – Ministry of Foreign Affairs and within Heading 21 – Ministry of Economy, funds will be allocated within the following appropriations:

- Programme 0007 (Heading 26) Funds are allocated within the existing budget regular allocations of MoESTD, no special funding is required;
- Programme 1509 (Heading 21) Incentives for the development of economic competitiveness. Funds will be allocated within the existing budget;
- Programme 1510 (Heading 21) Attracting investment;
- Heading 17) Support to the Cultural and Information Centre in London.
