Gaps and challenges regarding data in monitoring and reviewing the local implementation of the 2030 Agenda

- Limited available data
- Data disaggregation
- Poor administrative recording systems
- Poor management information systems for proper capture of administrative data.
- Acute shortage of statistical manpower in numbers and skills
- Low levels of coordination at the NSS level

What interventions have worked?

- Development of legal frameworks and institutional environment
- Development of Action Plans
- Increased government & partner interventions (funding & technical assistance) and commitment to production of high quality data
 - SDG Survey conducted
- Integrating SDGs indicators into various surveys
- Development of centralized data platforms
- Data accessibility enhanced


Data comparability and suitability for the local context

• Use credible source of information

- Use of sound methodology: Ensure that appropriate statistical methods are used and reported
- Uniformity in methodology: socioeconomic and demographic indicators need to be calculated using the same methodology to avoid statistical gaps
- In the process of producing comparative data, LGAs should subscribe to the framework of national statistical norms and adapt these norms to their LGA specificities.
- Review calculations and formulas for accuracy and statistical soundness;
- Review data and presentations of data (e.g., tables) for disclosure risk


Under-5 Mortality by Local Government Area

Deaths per 1,000 live births for the 10-year period before the survey (2019-20 GDHS)



Assistance during Delivery by Local Government Area

Percent of live births in the 5-year period before the survey assisted by a skilled provider (doctor, nurse, or midwife) (2019-20 GDHS)



Statistical annex for VLR report

- The statistical annex will probably contains a set of data
- Annex tables to illustrate VLR data
- Graphics
- Contain Data sources, classifications, and aggregation methodology
- Preferably at the end of the report
- Or as a separate report of its own

How best to analyze and communicate information on data so that it can be used as broadly as possible?

- LGAs should integrate the SDGs into their local development planning documents
- Capacity Building (increase their understanding of the SDGs)
- Use of SDG analysis metadata (Qualitative/Quantitative)
- Technology and Innovation (creation/functioning of websites/platforms) to enhance dissemination
- Dissemination workshops
- Increase the commitment to use data for evidence-based planning, M&E
