

Participation - Who can attend the UN 2023 Water Conference?



Relevant stakeholders, whose work is relevant to the 2023 UN Water Conference:

- non-governmental organizations,
- civil society organizations,
- academic institutions,
- the scientific community,
- the private sector and philanthropic organizations

Must be accredited in accordance with the provisions set forth in Annex II of A/RES/75/212.

Special Accreditation - Does my organization need to apply?



Don't need to apply for special accreditation:

- NGOs and other organizations in consultative status with ECOSOC.
- Organizations that have been accredited to the World Summit on Sustainable Development check list for details.

Not on these lists? Must apply for Special Accreditation to attend the UN 2023 Water Conference.

Entities not on the lists must apply for Special Accreditation to attend the UN 2023 Water Conference.

- First round now open deadline 15 July 2022.
- Outcomes of the first round of Special Accreditation are expected to be published by September 2022.
- Second round of special accreditation will be open later in 2022.

Special Accreditation - What is needed?



Applications will need to provide the following documents (all required):

- 1) proof of legal status;
- 2) a letter on official letterhead and signed by the Head of Organization requesting accreditation and;
- 3) a list of the key relevant activities undertaken by your organization in the past 12 months related to the Conference theme.
