01 Background

The implementation and monitoring of the <u>Sustainable Development Goals</u> (SDGs) require access to knowledge, not only for policymakers and leaders but also for all committed and engaged stakeholders around the world to ensure that nobody is left behind. <u>The SDGs Learning, Training and Practice</u> are a series of capacity building and knowledge workshops held as a <u>Special Event</u> at the margins of the United Nations <u>High-Level Political Forum</u> (HLPF) featuring speakers and experts from academia and other sectors on crucial topics related to the implementation of the SDGs. The SDG Learning, Training and Practice is organized by the <u>Division of Sustainable Development Goals</u> (DSDG) of the United Nations Department of Economic and Social Affairs (DESA) and the <u>United Nations Institute for Training and Research</u> (UNITAR).

The 7th Edition of the SDGs Learning, Training and Practice was held from 5 - 12 July 2022 in hybrid format, with two in-person sessions with broadcast, and the remaining sessions held in virtual format. The 2022 edition of the SDGs Learning, Training and Practice aimed at advancing knowledge and skills acquisition; networking; sharing experiences and peer to peer collaboration; learning about practical actions and best practices; capacity building; and sharing practical policy integration and coherence approaches. The sessions provided a space for HLPF participants and interested stakeholders to acquire practical knowledge while exchanging views on challenges faced and lessons learned.

All sessions were live-streamed and materials remain publicly available online.

02 Theme

The SDGs Learning, Training and Practice Special Event was aligned with the <u>2022 HLPF</u> theme: "Building back better from the coronavirus disease (COVID-19) while advancing the full implementation of the 2030 Agenda for Sustainable Development". It was also aligned with the set of SDGs reviewed in-depth at the 2022 HLPF:



SDG 4: Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all.



SDG 5: Achieve gender equality and empower all women and girls.



SDG 14: Conserve and sustainably use the oceans, seas and marine resources for sustainable development.



SDG 15: Protect, restore and promote sustainable use of terrestrial ecosystems, sustainably manage forests, combat desertification, and halt and reverse land degradation and halt biodiversity loss.



SDG 17: Strengthen the means of implementation and revitalize the global partnership for sustainable development.

O3 Selection of SDGs Learning Sessions and Programme

Between February and March 2022, DESA/DSDG and UNITAR lead a global open call for submissions of learning sessions proposals from stakeholders from different sectors. In total, 101 applications were received and reviewed based on their merit, relevance to the HLPF theme, expertise of organizers and willingness to produce the desired output. The 2022 SDGs Learning, Training and Practice comprised an opening session and ten learning sessions, organized by 40 partners from different sectors and fields of expertise.


O4 SDG Learning and Training Sessions Overview

The following sections bring information about all the 2022 SDG Learning, Training, and Practice courses. All materials are currently available <u>here</u>.

UN DESA/DSDG and UNITAR are grateful for the collaboration of all partners engaged in the 2022 edition of SDGs Learning, Training, and Practice. The 2022 SDGs Learning, Training, and Practice sessions received 2,561 registrations in total. The opening session and Session 1 were held in person at UNHQ in New York, with close to 800 participants watching the sessions via livestream on UN WebTV. The following nine sessions were held virtually, with an average of more than 170 participants attending each session via the Zoom Webinars platform. The recordings of the sessions on the UNITAR and DESA/DSDG's YouTube accounts accumulated 1850 views by 1 August 2022.




Analysis of Registration

In terms of regional participation (Graph 2), 37% of registered participants were from Asia, 28% from Africa, 16% from Europe, 9% from North America, and 9% from Latin America and the Caribbean.


Α quarter of the registered participants belonged to academic institutions, and another quarter Civil belonged to Society Organizations (Graph 3). The private sector was represented by above 15% of registered participants. 46% of the registrations were women (Graph 4).

<u>Opening Session - SDGs Learning and Training 2022</u>

11:00 a.m. | 05 July 2022

Opening session of the SDGs Learning, Training and Practice 2022, was held inperson at Conference Room 8, NYHQ with live stream on UN WebTV. This high-level session was moderated by H.E. Ms. Egriselda López, Permanent Representative of El Salvador to the United Nations. and featured welcoming remarks from H.E. Mr. Collen Vixen Kelapile, 77th President of the Economic and Social Council (ECOSOC), and Mr. Liu Zhenmin, Under-Secretary-General for Economic and Social Affairs, UNDESA, as well as Mr. Leonel Antonio Fernández Reyna, Former President of the Dominican Republic, as the keynote speaker. Mr. Fernandez highlighted the urgency to provide policy reform and resources to ensure universal quality education and stated that "...the learning expands inequality, which creates learning deficits with long-term and lasting consequences", with COVID-19 as our wake-up call.




<u>Session 5: Protecting our ocean: SDG 14 and its interlinkages</u>


<u>Session 6: Achieving gender equality: measuring progress and advocating for systems change</u>






07 Organizing Partners Survey

This analysis reflects the outcomes of a survey sent to all organizing partners of the 40 organizations that were involved in the planning and execution of the 2022 edition of the SDGs Learning, Training & Practice workshops. The survey aimed to better understand overall satisfaction regarding event execution, the effectiveness of support provided by UNITAR and UNDESA, and continuous challenges faced during planning and adaptation to an online teaching platform. 12 feedback responses were received - which can be potentially attributed to the holiday period. As a result of the limited sample size, the outcomes might not be completely representative for all organizing partners. The main outcomes are reflected below.

Satisfaction with session



Survey Outcomes:

100% of responding organizing partners were very or somewhat satisfied with the outcome of their session at the 2022 SDGs Learning, Training & Practice.

Satisfaction with UN support

92% of organizing partners were very or somewhat satisfied with the support provided by UNITAR & UNDESA to organize their workshop.

Based on their experience this year, 92% of responding organizing partners reported that they would be interested in applying to facilitate the SDGs Learning, Training & Practice workshops in the future.

Elements of organizational support ranked by usefulness to the organizing partners:

- 1. Preparatory organizational meetings
- 2. Registration and attendance
- 3. Day of event facilitation
- 4. SDGs website platform
- 5. Marketing materials (flyers and digital cards)
- 6. Publicity and outreach

Main challenges faced by organizing partners (in order):

- 1. Adjusting to the EDT time zone
- 2. Coordinating many partners in one session
- Duration of the workshop (would need more time)
- 4. Facilitating learning in a virtual setting instead of in-person workshops
- 5. Lack of clarity about how the main HLPF would be held
- 6. Limited time for the organization of the session

Main advantages for organizing partners to host a session (in order):

- 1. Opportunity of working in partnership with other organizations in setting up the learning session
- 2. Possibility of amplifying the outreach to a broader audience
- 3. Opportunity for hosting a 'Special Event' during the 2022 HLPF
- 4. Support from UNDESA and UNITAR in promoting the session
- 5. Having the recording of the learning session available at UN platforms

08 Final Comments

At its 7th Edition (in hybrid format), the SDGs Learning, Training and Practice HLPF Special Event continued to serve as a space for learning, exchange, and networking between partners and organizations from different sectors.

The SDGs Learning, Training and Practice depends on the commitment of partners to the SDGs and to their willingness of sharing their knowledge with practitioners all over the world. All sessions were recorded and will remain available to all interested stakeholders at both UNDESA and UNITAR webpages.

This was the first edition that included in person sessions since 2019. The number of registrations and participants also demonstrate that virtual engagement is still necessary and allow for broader participation.

UNDESA and UNITAR take duly note of the feedback received, which provides extremely helpful inputs on how to build further editions. UNDESA and UNITAR look forward to organizing the SDGs Learning, Training and Practice, as a Special Event of the HLPF in the coming years and welcome all organizing partners and new partners to submit their applications during future open calls for proposals.
