## SDG 7 Technical Advisory Group Meeting

13 July 2022, 09:30 - 10:30 EDT (NY Time)

S1522, UN Secretariat Building, New York (hybrid format)

## **Meeting Summary**

Members of the SDG 7 Technical Advisory Group (SDG7 TAG) met via a hybrid format, 13 July 2022, 09:30 to 10:30 EST. The list of participants and the agenda are in Annex 1 and Annex 2, respectively.

#### 1. Opening remarks

- a. The SDG7 TAG Co-Facilitators, Mr. Hans Olav Ibrekk and Ms. Sheila Oparaocha, opened the meeting by discussing the work ahead towards the sixth edition of the SDG7 Policy Briefs.
- b. The Secretariat summarized the outcomes from the 2022 Policy Briefs and presented a draft timeline for TAG activities towards 2023. The 2022 Policy Briefs serve as "proof of concept" for examining SDG interlinkages; the next edition will build on this by investigating synergies between SDG 7 and the remaining SDGs. Guiding questions for the discussion were presented:
  - i. How can we further improve the process of coordinating, producing and reviewing the Policy Briefs?
  - ii. How can we make the most out of the Expert Group on Interlinkages?
  - iii. How can we strengthen the link between the regional Policy Briefs and the Policy Briefs on interlinkages?
  - iv. How can we ensure coherence between the SDG7 Policy Briefs and the Global Roadmap for Accelerated SDG 7 Action? How can the Policy Briefs be linked to the Energy Compacts?

## 2. Adoption of Agenda

a. The draft agenda was adopted without amendment.

#### 3. Towards the SDG7 Policy Briefs 2023

- a. Upcoming points of engagement were introduced for discussion, in particular the HLPF and SDG summit in July 2023. As SDG 7 will be reviewed, the TAG's work should aim to inform the orientation of the ministerial deliberations and to influence the Ministerial Declaration, including through pushing the "strengthening interlinkages" angle.
- b. TAG members welcomed this focus and provided the following feedback:

- Leveraging the presence of Heads of State. Members proposed identifying 4-5 Heads of State to champion TAG's work at HLPF, or engaging their senior advisors in production or dissemination processes to create a sense of buyin. Members noted we must also not overlook collaboration with other decision-makers who are important for translating recommendations into implementation.
- ii. Improving coordination between the Tracking SDG 7 report and the policy briefs, and between regional policy briefs and global analyses. Members proposed that analytical studies could be standardized across products, with a focus on sharing regional-level best practices. Opportunities to find productive synergies with the processes for the 2023 Global Stocktake for the Paris Agreement and COP28 in Dubai were also proposed.
- iii. Creating a strategic outreach plan. Members called for more structure and focus in order for dissemination to effectively target various audiences. Specific suggestions included: considering formats such as press releases, op-eds or blogs; and proactively using partner organizations to disseminate key messages. Members proposed country-specific dissemination to better ensure that recommendations inform decision-making; Finally, it was noted that while Members are key in these efforts, DESA can play a central role in providing relevant material.
- iv. Recommendations for improving the review process. Members suggested improving on past reviewing processes by creating smaller expert groups on specific policy briefs/issues, and prioritizing preparation before meetings to enable strong suggestions during the meeting.

#### 4. Conclusions and Next Steps

- a. The Co-Facilitators thanked all participants for their commitment to the timelines and their quality of work and dedication and commitment, reiterating that TAG's success is attributable to the group's multi-stakeholder approach.
- b. For members' reference, the Secretariat will circulate a copy of the 2018 ministerial declaration which includes a one-page description of SDG 7.
- c. A TAG meeting will take place in October to coordinate the drafting process.
- d. The next Tracking SDG 7 report will be led by the WHO, with databases made available around the end of January.
- e. The Secretariat invited members to indicate their interest in hosting a face-to-face meeting within the next 12 months; the World Bank indicated tentative interest for Spring 2023.
