Concept Note: Study Tour of the Ministry of Trade, Industry, Regional Integration and Employment (MOTIE) to Senegal on Expanding Roles of Micro-, Small and Medium-sized Enterprises in Achieving Sustainable Development Goals (SDGs) in The Gambia

28 November to 2 December

Dakar, Senegal

1. Background

The Gambia is daily faced with new challenges derived from market transformations, technological advances, changes in food consumption patterns, and the increasing demand for stricter quality and health standards imposed by OECD importing countries. In addition, major developing countries such as China and India provide new market opportunities for The Gambia's agricultural exports but not without non-tariff barriers. To address these challenges, a change of perspective is needed to promote commercial agriculture and the development of rural non-farm activities. Private investment in appropriate technologies and scientific research to support the agricultural sector development in The Gambia requires effective policies and regulations and an enabling policy environment.

Currently, the Government of The Gambia has identified the agro-processing sector as one of the key pillars of the country's economic transformation. Senegal is a showcase of agricultural development in sub-Saharan Africa. The early recognition of the need to tackle the whole agricultural value chain, from inputs to production, processing and marketing, characterizes donors support as well as private investment in the agricultural sector in Senegal. Unlike Senegal, The Gambia is currently facing a decline in traditional export sectors, particularly groundnuts and fisheries, a situation Senegal experienced in the early 2000s but managed to overcome by investing in the agro-processing sector. Due to the investment and relevant policy support, Micro-, Small and Medium-sized Enterprises (MSMEs) in the horticulture and cross-border trade sectors in Senegal are better organized and more empowered than in The Gambia, who have succeeded in increasing production and export volume, while satisfying the stringent sanitary requirements of the OECD markets.

The private sector in Senegal generally features cash crops and links farmers to markets in a better and more organized environment. Private sector firms, especially MSMEs, provide critical support to sustainable development in Senegal, in areas of input supply and the provision of market information and technical advice to farmers. The export-oriented agro-processing sector specializes in groundnut oils and canned fish. The sector also serves the domestic market featuring tomato concentrates, sugar refining, flour milling, milk powder, soda water and other beverages. These agro-industrial firms are located in the Dakar area and benefit from proximity to the port of Dakar. Local MSMEs engaged in processing domestic agricultural products, such as local cereals, fruit and vegetables, fish and milk are also present in Senegal. It is for this reason that Senegal was identified by the Ministry of Trade, Industry, Regional Integration and Employment (MOTIE), The Gambia for this proposed study tour to learn the good practices of Senegal as well as to find ways that will address the challenges that The Gambia and Senegal are facing together regarding the ECOWAS Trade Liberalization Scheme (ETLS), Inter State Road Transit Scheme (ISRT) and how best to leverage opportunities presented by the African Continental Free Trade Area Agreement (AfCFTA).

Senegal also established strong institutional structures to support and facilitate the development of MSMEs in the agriculture and agro-industry sectors. The Ministry of Industry and MSMEs, Senegal, has a strong agro-processing research center in Dakar promoting research in agro-processing and agro-processing equipment. These are experiences that could help strengthen capacities of policymakers and MSME entrepreneurs in The Gambia and other developing countries on boosting the agriculture and agro-processing industry.

2. Rationale and potential benefits of the study tour

The Ministry of Trade, Industry, Regional Integration and Employment (MOTIE) of The Gambia is committed to enhancing productivity, resilience and competitiveness, as well as strengthening capacities of Micro-, Small and Medium-sized Enterprises (MSMEs) in The Gambia. MSMEs are multi-sectoral in The Gambia, operating in broad economic sectors of the country. They are found in both rural and urban settings. When well coordinated and integrated policies are effectively implemented, MSMEs can serve as a catalyst for advancing progress towards

Sustaianble Development Goals (SDGs) in The Gambia, in particualr, in areas of poverty alleviation, decent employment, income creation and inclusive wealth distribution. However, to successfully design and implement MSME supporting policies, it is imperative to understand certain prerequisites, acquire relevant knowledge on the cutting-edge and strengthen capacities of policymakers and MSME entrepreneurs alike on how MSMEs can be capacitated to stay resilient to economic shocks and uncertainties, and at the same time capture high-value market opportunities emerging from the integration of global and regional markets, such as the African Continental Free Trade Area (AfCFTA). Knowledge exchange across countries and among key stakeholder groups are necessary to share good practices and strengthen capacities. The exchange can be achieved through study tours in countries with good track records and experience in implementing effective MSME supporting policies.

In view of the above, Senegal is identified by MOTIE, relevant government departments and MSME Associations in The Gambia as a country to visit, learn and exchange good practices. Considering the successful collaboration between MOTIE and the Division for Sustainable Development Goals of the United Nations Department of Economic and Social Affairs (DSDG/DESA) in the past years, MOTIE would like to request the support of DSDG/DESA to organize this study tour.

The study tour will contribute to the following potential benefits for participating Gambian policymakers and private sector representatives, including:

- Strengthened capacity of policymakers to design and deliver effective MSME supporting policies in The Gambia in a demand-driven approach through exchanging good practices with Senegalese counterparts;
- Strengthened capacities of MSME entrepreneurs in areas of financial planning, marketing, book-keeping, supply chain and cost-management;
- Harnessing knowledge learnt from the study tour, create a more structured and coordinated MSME supporting policy system in The Gambia that will provide effective and demand-driven Business Development Services (BDS);

- Create linkages between Gambian MSMEs and regional and international enterprises as
 well as facilitate their active participation in regional and global market integration
 processes to capture high-value opportunities while boosting their resilience to market
 uncertainties and economic shocks;
- Exchange good practices to facilitate the strengthening of the MSME sector in The Gambia with contributions to poverty reduction and advancing progress towards Sustainable Development Goals in The Gambia.

3. Objective of the study tour

The specific objectives of this study tour include:

- To learn the strategic policy interventions launched by Senegal that led to the growth of the national economy with expanded MSME contributions
- To understand the roles and contributions of Government, parastatals and private sector in contributing to the effective planning and implementation of MSME supporting policies in Senegal
- To build contacts with Senegalese counterparts and expand cross-border trade opportunities between the Gambian and Senegalese MSMEs
- To explore with Senegalese counterparts how their experience could be replicated in developing countries such as The Gambia.

Overall, the study tour will help participants to learn about Senegal's experience promoting the contributions of MSMEs to inclusive growth, MSME entrepreneurship, building MSME clusters, as well as putting in place institutional arrangements to support the effective design and implementation of MSME supporting policies. MOTIE will send a study tour report to DSDG/DESA with detailed records on key takeaway messages from the study tour and follow-up measures.
