- High-level International Conference on the International Decade for Action "Water for Sustainable Development", 2018–2028 (Dushanbe 2022)
- High-level Symposium on Water at the UN Ocean Conference (Lisbon 2022)

By the request of the Co-Hosts, the ambitions coming from these events were organized according to the SDG 6 Global Acceleration Framework:

- Financing
- Data and information
- Capacity development
- Innovation
- Governance

Interactive Dialogue 5: Opportunities for progress

Highlighted calls to action under each accelerator

Financing: Not only more financing, but effective use of financing and good governance around its regulations and institutions. Earmark funds for communities in situation of vulnerability.

Data and information: Disaggregate data to "leave no one behind," improve data collection efficiency, democratize data and use data better for policy making.

<u>Capacity development</u>: Not only strengthen, but enable capacity development. Bolster all types of education related to water (vocational, technical, etc.). Focus on marginalized and allow for Global South leadership in this area.

<u>Innovation</u>: Innovate both governance and financial systems to work in more effective ways. Innovate educational systems to keep pace with new skills demands and water use efficiency in ways that incorporates sustainability more than just what is produced per unit of water

Governance: More inclusive governance, increase coordination across sectors, improve global water governance, especially with regards to the outcomes of the UN 2023 Water Conference.

Interactive Dialogue 5: Recommendations (1)

- 1. Improve the interface between knowledge, policy and action to address water challenges of the future.
- 2. Better equip the world with skilled professionals at all levels to address current problems and future demands. Align education and labour to attract, educate, train and retain skilled professionals, especially women, as demands change over time.
- 3. The water community needs to innovate in all themes, which includes the other four accelerators of the SDG 6 Global Acceleration Framework. The effort to do so needs to be intensified many times over and create new ways to develop capacities and upscale and sustain solutions.

Interactive Dialogue 5: Recommendations (2)

- 4. Communities and groups of people in situations of vulnerability and/or marginalization (i.e., women, youth, Indigenous Peoples, people living with disabilities, etc.) need to be not only prioritized, but included in decisions that impact them.
- 5. Cooperating and coordinating across sectors is no longer a luxury, but an imperative. While the water community understands water's importance to sustainable development, it needs to be consistently proactive in its overtures to engage with other sectors.
- 6. While water and sanitation solutions are very local in nature, there is still much work to be done at the global level to create the best supporting structure to assist where help is needed most and to move forward together towards sustainable water and sanitation management worldwide:
 - Consider a Special Envoy on Water
 - Strengthen UN-Water and enhance UN system-wide approach on water
 - Establish regular intergovernmental meetings on water, potentially alongside the High-level Political Forum
 - Develop mechanism that will facilitate the interaction of water with other international initiatives

Interactive Dialogue 5: Guiding questions

- 1. How can Member States, the Decade and the UN system help implement and follow up on the commitments made in the Water Action Agenda? What global governance and political leadership is needed? How can the stronger accountability and incentives needed for SDG 6 delivery be embedded and scaled through the Water Action Agenda?
- 2. How effective is the Decade at the political level? What would be success or failure of the Decade in five years' time?
- 3. How can the water community best utilize a Special Envoy for Water to raise the profile of water and accelerate the achievement of SDG 6?
- 4. How do you see water in a post-2030 Agenda?
- 5. How can we strengthen multilateralism around water through collaboration between national and multilateral actors? How can we strengthen collaboration/connections between the local and global levels?



Principals should focus on answering these questions when formulating their interventions
