Voluntary Local Reviews originated from the need to complement Voluntary National Reviews (VNRs), to further SDG localization, and to put localities in the driver's seat.


They serve many functions. Including:

- 3. Tool to engage stakeholders

- 4. Build a roadmap towards specific targets
- 5. Share lessons with others
- 6. Link with national SDG processes and reporting obligations


VLRs in Africa have Grown Exponentially

- Completed VLRs: Accra, Harare, Ngora, Victoria Falls, Yaoundé (supported by ECA); Cape Town, 4 in Kenya
- Current VLRs: 4 in Benin, Brazzaville, 4 in Gambia, Ghana, 4 in Zimbabwe, many in Uganda, Kenya, Mozambique, South Africa, and several others



- In general, did the subnational government adapt any of the SDGs or Agenda 2063 goals to the local context to match jurisdictional boundaries?
- How has the VLR process influenced local development plans or processes?

VLRs, SDGs & Agenda 2023 Implementation – Experiences

Ngora District, Uganda

Implementation of Sustainable **Development Agenda (SDGs, Agenda** 2020 and Agenda 2063) in Ngora district has been an important aspect yet ignored. This has been done on implementation of day to day activities even unknowingly.... This VLR report will therefore act as tool to inform Ngora District Development Plan 2020/21 to **2024/25**, also guide in the allocation of resources. The report also scarce highlights the level of effort that must be demonstrated by all stakeholders to cause a positive change in especially sectors lagging behind in performance like Agriculture, Health and Roads.



Yaounde, Cameroon Gilbert Tsimi Evouna, Government Delegate to the Yaoundé City

In 2020, the city is reviewing its Urban Master Plan, with the intention to reinforce its coherence with the city development strategy. The participation of Yaounde City in the Voluntary Local Review (VLR) of the Sustainable Development Goals seeks to inform the review of this master plan, but also to inform revisions of the strategy in order to place the city of Yaounde on the path to sustainability.

VLRs, SDGs & Agenda 2023 Implementation – Experiences

The Accra Metropolitan Assembly's **Development Policy is underpinned by** the SDGs and Africa Union's Agenda **2063.** The Assembly's medium-term development plan and budgeting processes are all aligned to the two agendas. The VLR report provides an overview of the metropolis' steps and progress towards achieving the SDGs and the African Union Agenda 2063, as well as highlight the inclusivity in the planning process with the objective of bringing development closer to the people.

The VLR framework have been recognized as an important tool for meaningful multi-stakeholder engagement and resource mobilization advance to the implementation of the aforementioned agendas. This process has enabled Accra Metropolitan Assembly to **build** capacity in monitoring and reporting of the SDGs and Agenda 2063. The Assembly would further leverage on opportunities thereof to accelerate the implementation of the SDGs and Agenda 2063.


Victoria Falls Municipality has mainstreamed the 2030 Agenda and Agenda 2063 into its five-year 2018–2022 strategic development plan. The plan is implemented currently being through planned projects, policies, programmes and procedures ... More than 75 per cent of the Development Goals Sustainable are reflected in the strategic plan.



Horizontal inter-agency coordination and communication mechanisms between the national level and Victoria Falls Municipality have been made possible through a national steering committee for the 2030 Agenda for Sustainable Development and local subcommittees established for mainstreaming the Sustainable Development Goals into the plan and attaining them.

VLRs, SDGs & Agenda 2063 Implementation

Generally, we find countries' development plans tend to be more aligned with the SDGs than Agenda 2063, necessitating more awareness generation for Agenda 2063






Figure 2: Development Plan Alignment with SDGs and Agenda 2063 for Ethipia

Looking Forward: Local and Regional Governments can be strengthened to be effective contributors to SDGs and Agenda 2063 Coordination, Implementation and Reviews

Promote a national enabling environment for subnational reporting by:

- Including adaptation to local contexts as a substantive dimension in national development strategues;
- ii. Mainstreaming SDGs and Agenda 2063 into national local processes – including monitoring;
- iii. Developing a multilevel collaborative culture of governance

Strengthen voluntary local reviews and their environment by:

- i. Creating local mechanisms for structural and periodic monitoring and review;
- ii. Promoting inclusive participation;
- iii. Strenghtening the data environment at the local level; and
- iv. Encouraging the capacities of local government associations



Enhance the connection between local and national reviews by:

- i. Mobiliizing adequate support and resources to strengthen local reporting capaicities; and
- ii. Facilitating collaborative and multilevel data environments.

Create an international environment to support subnational reporting by:

- . Supporting the participation of local governments in regional and global international processes;
- ii. Continuing to develop, refine and disseminate local review guidelines; and
- iii. Leverage existing UN frameworks like the UNECA's IPRT that supports multipurpose agenda alignment, review and reporting.
