Creative AGE for SDGs: Accelerating Growth of MSMEs in the Philippines Consultation Workshop and Culminating Event Updated as of March 1, 2023

I. BACKGROUND

Micro, Small and Medium-sized Enterprises (MSMEs) are the engine of job creation, economic growth, and poverty reduction in the Philippines. However, the creative industry sector and MSMEs active in this sector area are vulnerable to economic shocks and uncertainties from disasters, especially the outbreak of the COVID-19 pandemic and natural disasters. In addition, the World Risk Index 2022 ranks the Philippines as first (1 st) in the world in its vulnerability against natural disasters. These circumstances have highlighted the urgent need to implement robust policies and good practices aimed at strengthening MSME resilience.

Bringing onboard relevant MSME stakeholders in the Philippines in an inclusive manner, the consultation workshop will disseminate the impact of the Creative AGE for SDGs programme among MSME entrepreneurs filling up identified gaps for women and youth-led MSMEs, as well as strengthening the action plan and the result monitoring framework with inclusive stakeholder input. All these shall accelerate the progress and bolster SDGs towards the areas specifically on poverty reduction, inclusive economic growth and decent work, gender equality and sustainable cities and communities.

II. OBJECTIVE

The primary objective of the consultation workshop and culminating event is to gather key stakeholders in the creative industry in the Philippines to present and discuss the updates on the implementation of the Philippine Creative Industries Development Act (PCIDA), exchange ideas and/or develop an action plan on the integration of the 2030 Agenda for Sustainable Development in strategies supporting the creative sector, and presenting the outputs and good practices of the MSME Creative Champions from the "Creative AGE for SDGs: Accelerating Growth of MSMEs in the Philippines" Programme. Key stakeholders will be representative of national and local government agencies plus members of the private sector. The 4-day event will also explore potential gaps and challenges constraining MSME resilience and their contributions to the shared sustainable goals, especially of women and youth-led MSMEs in the creative industries.

Results of the activities will also feed policy recommendations on the drafting of the MSME Development Plan 2023-2028.

Through intensive knowledge exchange and dialogue among attendees and stakeholders, the event will:

- Facilitate strategic discussions on how creative MSME enablers will accelerate support to the creative sector while incorporating the 2030 agenda in its strategies;
- Showcase the new and innovative business model of the MSME Creative Champions and document good practices to other MSMEs and stakeholders:
- Recommend appropriate actions required to develop and implement criteria and indicators in fostering Creative Champions to other cities/municipalities in the Philippines.

III. ATTENDEES

It is anticipated that there will be a total of sixty (60) participants to the consultation workshop and culminating program, including the MSME Creative Champions together with their DTI creative focals who supported them throughout the programme.

The DTI-Competitiveness and Innovation Group (CIG) along with selected Local Government Unit (LGU) stakeholders from the eight (8) localities will be invited to participate in the discussion of the programme results and presentation by the beneficiaries. Selected representatives of LGUs that are in a position to share good practices will also be invited.
