- ❑ Formulation of programmes and sub-programmes
- ❑ Identification of implementable activities (AAPs)
- ❑ Designing of Monitoring and Evaluation framework to assess progress of implementation
- ❑ Formulation of communication strategies to disseminate 2022-2025 MTDP to other stakeholders

MTDP PLAN IMPLEMENTATION AND SDGs REPORTING

- ❑ MTDP is faced out into 4 Annual Action Plans
- ❑ The AAP is divided into 6 development dimensions, aligned goals with SDGs, AU Agenda 2063 and sets of implementable activities under each goal.
- ❑ There are sets of core and district specific indicators designed to track level of progress for the AAP activities.
- ❑ Data is collected at the end of each year to ascertain the level of achievement for the AAP
- ❑ Annual progress reports are prepared on the level of achievement of the AAP goal already align with the SDG and AU agenda 2063

SPECIFIC SDG INTERVENTIONS IN THE MUNICIPAL

1. Climate Change

- ❖ REDD+Programme – climate change awareness campaigns, fire prevention and education, climate change advocacy campaigns and forest monitoring. (SDG 13.3)
- ❖ National Climate Change Adaptation Programme – Implementation by EPA with an objective for effective climate adaptation, social development and mitigation in the district. (SDG 13.1)

2. Job Creation

- ❖ Care Ghana Programme - The Municipal Assembly in collaboration with care Ghana International have trained a total of 1,000 women in 35 communities in seam stressing and bakery. Start-up kits / tools have been distributed to all beneficiaries. (SDG 8.5)
- ❖ Municipal Assembly's EU Fund – Provision of credit facilities to rice, oil palm and vegetable producers averaging 50 – 100 farmers annual for increased production. (2.3)

3. Integrated Social Services (ISS)

- ❖ Eradication of child labour, promote child protection and support to vulnerability especially children (SDG 5.3)
