

PARTICIPATORY PLAN PREPARATION PROCESS

- Both quantitative and qualitative data were collected
- Participatory Learning and Action(PLA) approached used to interact with the community members

- Data were also sourced from primary and secondary sources
- Secondary sources of data gathered include literature from previous plans, CSOs and Departmental profiles in the Municipality among others.

PARTICIPATORY PLAN PREPARATION PROCESS CONT.

• The Planning team visited communities under Zonal Council areas in the municipality and interacted with communities' members and their representatives to discuss issues relating to the MTDP and to solicit their inputs into the plan

PARTICIPATORY PLAN PREPARATION PROCESS CONT.

Their inputs as a primary source was gathered through

- Focus group discussions
- Transect walks
- Interview, and
- Community for a among others.
- This system provided a participatory approach to the plan to enable the community own and participates in its implementation.

PARTICIPATORY PLAN PREPARATION PROCESS CONT.

• The public hearings organized in the communities also enabled prioritization of their needs identified. In all 46 communities in the municipality were visited

• Heads of Departments and Civil Society organizations submitted inputs into the plan in the form of written memoranda.
