

Arrangements for accreditation and participation of non-governmental organizations, major groups and other relevant stakeholders in the fourth International Conference on Small Island Developing States

Note by the Secretariat

In its resolution adopted on 30 May 2023 concerning the arrangements for accreditation and participation of non-governmental organizations, major groups and other relevant stakeholders in the fourth International Conference on Small Island Developing States (see [A/CONF.223/2024/PC/L.1](#)) the Preparatory Committee of the International Conference decided, inter alia, that “other relevant stakeholders, including the non-governmental organizations not in consultative status with the Economic and Social Council, wishing to attend and contribute to the Conference, and whose work is relevant to the subject of the International Conference, may participate as observers in the International Conference, as well as in the preparatory meetings, in accordance with the provisions contained in part VII of Economic and Social Council resolution 1996/31, subject to the approval of the Preparatory Committee or the General Assembly”. In the same resolution, the Committee also stated that the secretariat of the Conference would “be responsible for the receipt and preliminary evaluation of requests for accreditation to the Conference and its preparatory process” and would “review the relevance of the work of the applicants on the basis of their background and involvement in sustainable development issues, in particular in the process of follow up to the Barbados Programme of Action for the Sustainable Development of Small Island Developing States, the Mauritius Strategy for Implementation and the SIDS Accelerated Modalities of Action (SAMOA) Pathway”.

The secretariat received 155 applications by the 10 November 2023 deadline and has organized the requests into three separate annexes. Annex 1 contains the list of the non-governmental organizations, major groups and other relevant stakeholders recommended by the secretariat for accreditation in the fourth International Conference on Small Island Developing States. Annex 2 contains the list of submissions that were not evaluated by the secretariat because the organizations: (a) were Government entities (b) were Intergovernmental Organizations or other entities already accredited to attend the Conference or (c) were NGOs in consultative status with the United Nations Economic and Social Council. Annex 3 contains the list of submissions not recommended by the secretariat because the organisations: (a) did not meet the criteria established in part VII of Council resolution 1996/31 or (b) have withdrawn their application.
