Participatory methodology - key concepts

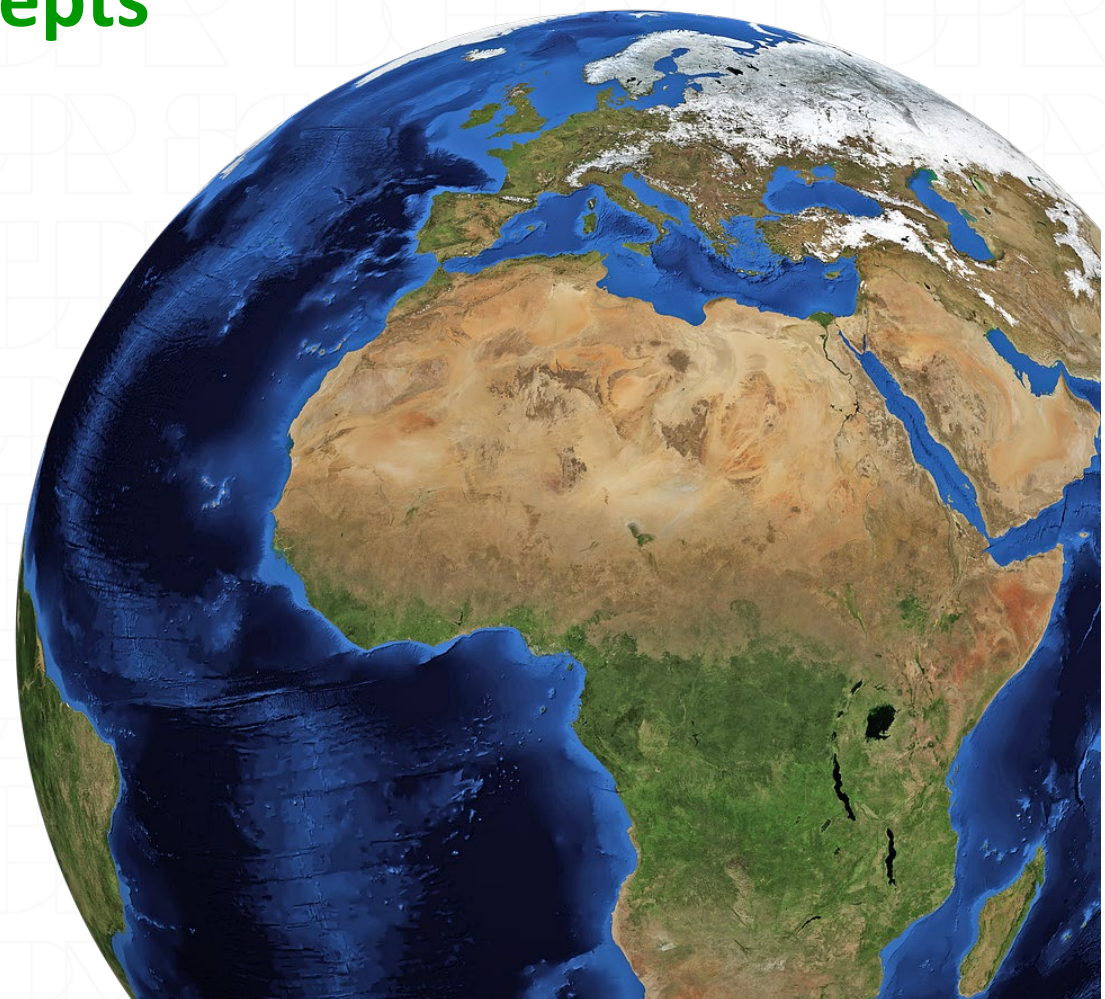
- **Country report:** that represents the efforts of the Brazilian State and Society;
- **Focused on priorities:** combating hunger and poverty; confronting multiple inequalities, combating racism, environmental protection (special attention to the Amazon and Cerrado); and decent work;.
- **Intersectoral:** built by different areas of government;
- **Based on official data:** technical and statistical coordination of IPEA, IBGE and FIOCRUZ;
- **Grounded on Social participation:** various consultation and social dialogue processes;
- **Mobilizing factor:** more than a report, a process that mobilizes governments at the 3 spheres (federal, state and municipal), the various public bodies and civil society.
- **Continuous process:** there will be 2 reports, 2024 and 2026.

Participatory methodology - key concepts

- **Official statistics** - IBGE (Brazilian Institute of Geography and Statistics)
- **Federal government budget** - Multi-year Plan - Ministry of Planning and Budget
- **Ministerial priorities** - Focal points of the 38 ministries
- **Multiple Forms for consultation on good practices** - responses systematized by CNODS
