

VLR Momentum in Africa Region



- In the Africa region, VLR momentum is high. More than 20 completed, and more than 30 underway
- VLR contributed to 2024 VNRs for Uganda and Zimbabwe
- Ghana, Zimbabwe, and Uganda national SDG coordination mechanisms facilitate the conducting of VLRs across the countries
- National capacity building workshops on localization involve broad stakeholders, including representatives of vulnerable groups (youth, persons with disabilities, women)

VLRs & VNRs in Latin America and the Caribbean

- 85 VLRs in 67 locations in 11 countries: Argentina, Bolivia, Brazil, Colombia, Costa Rica, Ecuador, Guatemala, Mexico, Paraguay, Peru and Uruguay

- Community of Practice and regional, (tri-)national and local capacity workshops to enhance vertical integration across different levels and launch of a regional VLR guide



VNR-VLR integration in Asia and the Pacific 2016-2023



- Medium to high degree of LRG consultation
- Low degree of LRG consultation
- No LRG consultation
- No elected LRGs

- Local governments are not sufficiently engaged in VNR processes in Asia and the Pacific
- Only 30% of VNR process in the region included the consultation of LRG with a medium to high degree
- Fiji VNR (2023) featured 'localization' not as an isolated example but as part of the 'means of implementation' and stating that Local SDG Action Begins with Voluntary Local Reviews

Good VLR practices leading to concrete impacts: selected examples

- Scale up to more cities
- Regional VLR guidelines
- Build local VLR capacities
- Robust data collection and monitoring frameworks at local level
- Multi-stakeholder coalitions around SDG localization
