Excellency,

We are pleased to write to you in our capacity as co-hosts of the 2025 United Nations Conference to Support the Implementation of Sustainable Development Goal 14: Conserve and sustainably use the oceans, seas and marine resources for sustainable development (UNOC 3).

In accordance with General Assembly resolution 78/128 and as communicated in the 7 March 2024 letter of the President of the General Assembly, the preparatory meeting of the Conference was convened on 2 July 2024 at the Trusteeship Council Chamber, at the United Nations Headquarters, in New York. The meeting considered the themes for Ocean Action Panels to be held at the Conference, as contained in the Secretary-General's background note for the preparatory meeting (A/78/880), and elements for a declaration.

The Special Envoys for the Ocean of Costa Rica and France, Ambassador Georgina Guillén Grillo and Ambassador Olivier Poivre d'Arvor expressed their appreciation to delegations and other stakeholders for their invaluable insights to these proposed themes and for the constructive spirit of the discussions.

Based on these deliberations and upon further reflection and consultation, the co-hosts would like to propose the following slightly revised themes:

- a. Fostering sustainable fisheries management including supporting small-scale fishers.
- b. Conserving, sustainably managing and restoring marine and coastal ecosystems including deep-sea ecosystems.
- c. Harnessing and supporting all forms of cooperation, especially at the regional and subregional level.
- d. Preventing and tackling marine pollution of all kinds, in particular from land-based activities.
- e. Leveraging ocean, climate and biodiversity interlinkages.

- f. Advancing sustainable ocean-based economies, sustainable maritime transport and coastal community resilience leaving no one behind.
- g. Promoting the role of sustainable food from the ocean for poverty eradication and food security.
- h. Increasing ocean-related scientific cooperation, knowledge, capacity building, marine technology and education to strengthen the science-policy interface for ocean health.
- i. Enhancing the conservation and sustainable use of oceans and their resources by implementing international law as reflected in the UNCLOS.
- j. Mobilizing finance for ocean actions in the support of SDG14.

The order of the Ocean Action Panels will be subject to change depending on the organizational and logistical planning.

As mentioned in the closing segment of the preparatory meeting, these proposals constitute our best effort in including your important inputs and priorities and are an effort for consensus. It is our expressed hope that with flexibility from all sides we can reach agreement on these important topics.

The abovementioned themes are therefore placed under silence procedure until Wednesday, 10 July 2024, 6 p.m. EST.

Furthermore, please note that if the silence procedure concludes successfully, the final themes will be circulated to the membership via letter of the President of the General Assembly. The Secretariat will then begin the substantive preparations, including a call for inputs to the concept papers, nominations for panelists and expression of interest in co-chairing the Ocean Action Panels.
