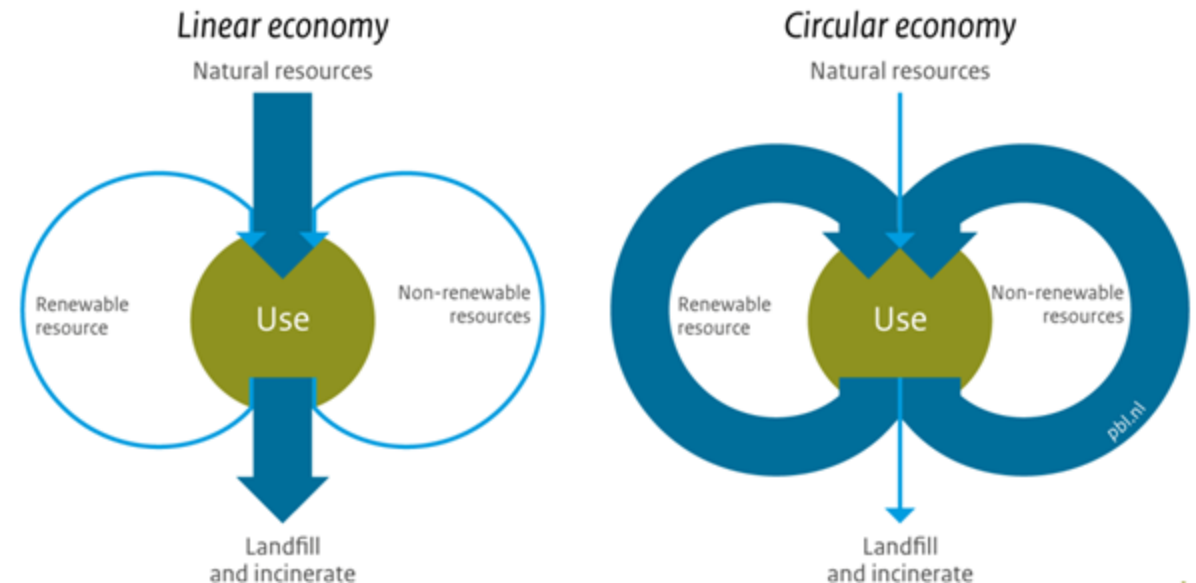


What imperatives motivate this guidance?

1. Localizing and achieving the Sustainable Development Goals (SDGs) at the local level
2. Local recovery from shocks and local transitions to sustainable local economies in a manner that is green, circular and just.
3. Strengthening resilience, through local disaster risk reduction (DRR) and climate change adaptation (CCA).

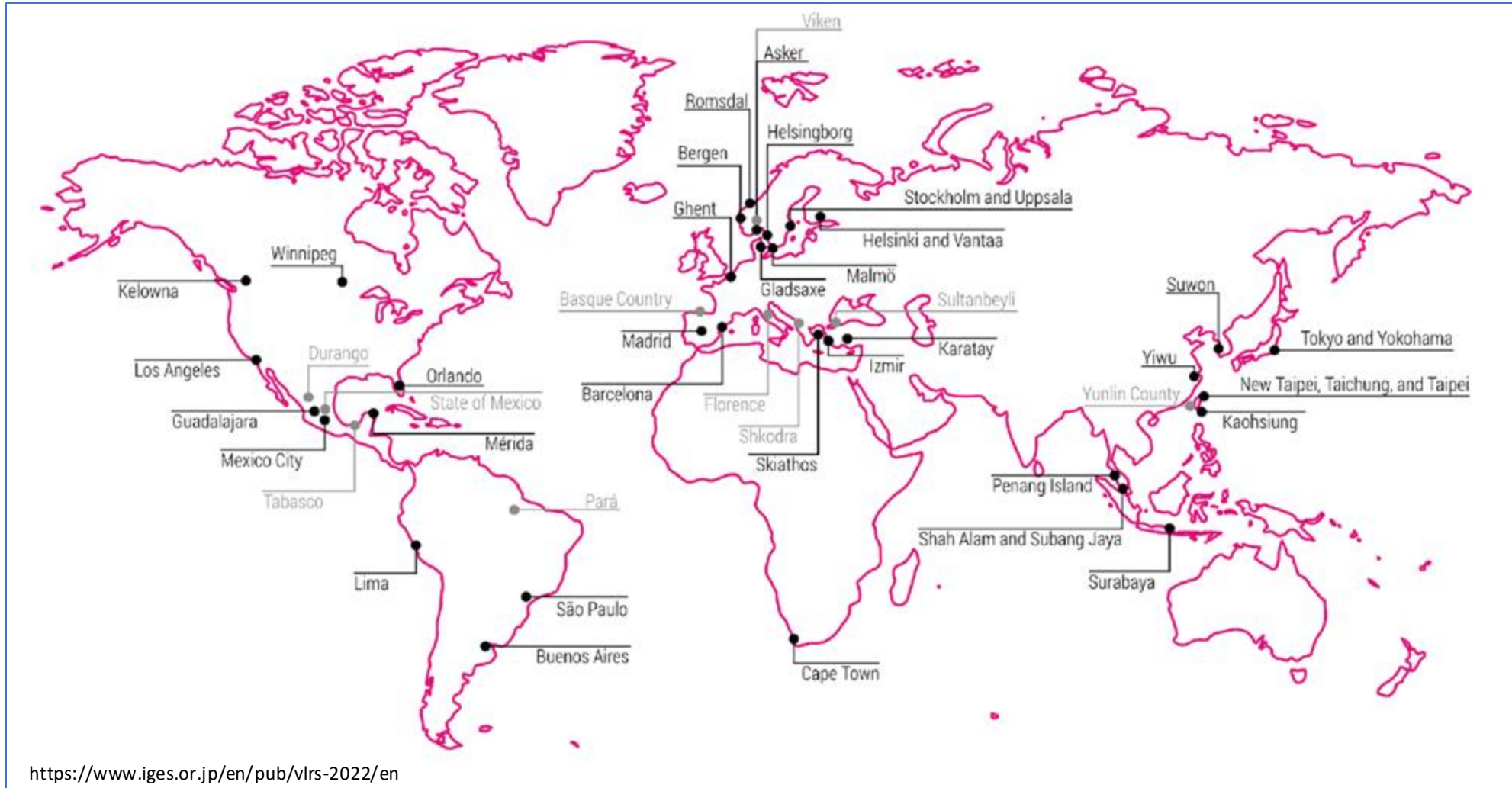

Given the growth in VLRs as a practical reporting mechanism for local governments and organizations, the VLR represents a key leverage point for accelerating progress toward the SDGs and the transition toward green, sustainable, and resilient recover & transitions at the local level.

What is a Voluntary Local Review (VLR)?

- **Voluntary National Reviews (VNRs)** presented annually by countries to the UN High-Level Political Forum (HLPF) on progress toward the SDGs
- Local and regional governments are increasingly engaging in their own subnational reviews...
- **Voluntary Local Reviews (VLRs)** have proven useful for cities and regions to localize SDGs and demonstrate the commitment and innovation of local government.
- A strong VLR process **informs the VNR and local government** planning, budget and reporting
- An enhanced VLR process **supports green, sustainable, and resilient recovery & transition** at the local level.

Proposed VLR Content for the UN ECE Region

- **Part I.** City vision and goal statement.
- **Part II.** Economic and social situation in the city, including legal, financial and institutional framework for city development.
- **Part III.** Assessment of city performance using KPIs for Smart Sustainable Cities, including progress towards achieving SDGs at the city level.
- **Part IV.** Recommendations from the assessment for achieving SDGs at the city level and proposals for programmes and projects to be developed and implemented to further progress towards SDGs and make cities smart and sustainable.
- **Part V.** Financial framework for supporting city efforts to achieve the SDGs and implement proposed programmes and projects, including SDG budgeting.
- **Part VI.** Conclusions and proposals for next steps.

Understanding the VLR Process

- A. Undertake broad-based consultation
- B. Establish a coordination mechanism for the VLR preparation
- C. Data collection
- D. Preparation of the VLR
- E. Validation of the VLR (via a stakeholder workshop)
- F. Identifying innovative financing mechanisms for covering funding gaps and mainstreaming VLR recommendations



To support sustainable, green, and resilient recovery & transitions, VLRs should: ...

Generally,

- ✓ create shared socio-economic and ecological value for local communities and vulnerable groups;
- ✓ promote participatory and inclusive approaches and leaves no one behind;
- ✓ be supported by evidence;
- ✓ be forward-looking, flexible, and adaptive for green transitions as well as recovery and resilience from disasters and shocks; and
- ✓ explore innovative financing sources and instruments.



To support sustainable, green, and resilient recovery & transitions, VLRs should: ...

Specifically,

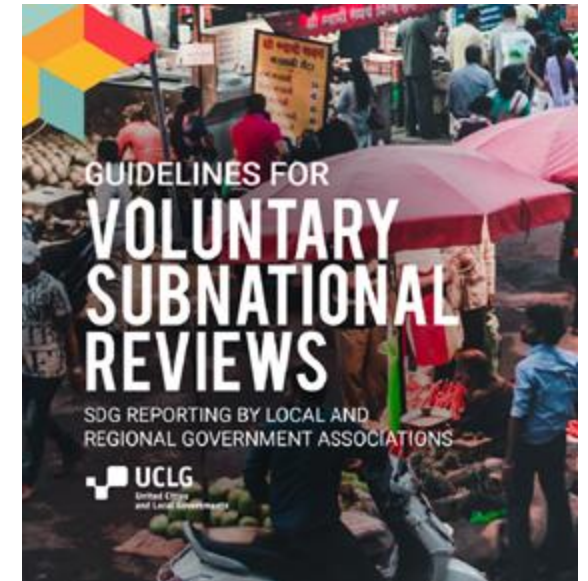
- ✓ set a course for **local green recovery and transitions**,
 - aimed at long-term structural reforms and a transformative shifts towards sustainability, biodiversity protection, and climate neutrality; and
- ✓ **strengthen local resilience**,
 - aimed at climate change adaptation for resilient infrastructure and communities
 - mainstreaming disaster risk reduction for reducing hazards, exposure, and vulnerability to other, non-weather related hazards,
 - including the use of nature-based solutions.



To support sustainable, green, and resilient recovery & transitions, VLRs should: ...

Practically,

- ✓ link to the Voluntary National Review and Voluntary Sub-national Review,
 - aimed at creating links to the content and process for a VNR or VSR;
- ✓ be practical and action-oriented for use by local government,
 - aimed at using the VLR to help inform local government planning, budgeting, and reporting; and
- ✓ support the means of implementation,
 - aimed at using the VLR to assess and inform financing sources and instruments, technology development and transfer, local trade and markets, and measuring local SDG progress using high-quality, timely, reliable, relevant, and disaggregated data.
