Commitment to the SDGs at the Local Level

- **Alignment of Local and National SDG Plans:** Municipalities are aligning their development strategies with the global SDGs and the national development framework. There is a consistent effort to integrate SDGs into local governance policies, plans, and service delivery.
- **Mainstreaming SDGs:** Municipalities have mainstreamed SDGs across various local government processes, ensuring that each local government unit considers the SDGs in its decision-making, from infrastructure projects to community health programs.



Leave No One Behind (LNOB)

- **Inclusion and Equity:** There is a strong emphasis on **inclusive development**, ensuring that vulnerable and marginalized groups, including women, children, persons with disabilities, and rural populations, are included in decision-making processes. Many municipalities have developed specific programs to address the needs of these groups.
- **Targeted Social Programs:** Several municipalities have introduced targeted programs for poverty reduction, gender equality, education, and youth empowerment, focusing on leaving no one behind in the development journey.

- **Gender Mainstreaming:** Local governments are making strides in **mainstreaming gender in their policies and programs**, especially in sectors such as healthcare, education, economic empowerment, and governance. Gender-focused initiatives are addressing issues like gender-based violence, women's leadership, and access to resources.
- **Women's Economic Empowerment:** Some municipalities have focused on **empowering women through entrepreneurship**, leadership, and employment initiatives. Gender-sensitive budgeting and policy planning have been adopted to promote equality.

Sustainable Economic Development and SMME Support

- **Local Economic Development:** Municipalities have prioritized **economic growth at the local level**, with an emphasis on creating jobs, supporting small, medium, and micro enterprises (SMMEs), and fostering entrepreneurship.
- **Public-Private Partnerships (PPPs):** Some municipalities have engaged in partnerships with the private sector to stimulate local economic growth, including innovative financing models and infrastructure development programs that contribute to SDG achievement.
- **SMME Support:** A focus on **SMME development** through access to financing, skills training, and creating an enabling environment for small businesses has been central to local economic development plans.

Climate Action and Resilience Building

- **Climate Change Adaptation and Mitigation:** Local governments are taking steps to address **climate resilience** through **climate change adaptation programs** and efforts to mitigate environmental risks. This includes investments in renewable energy, energy-efficient buildings, water conservation, and waste management programs.
- **Green Cities:** Many municipalities are implementing **sustainable urbanization practices** with a focus on building “green cities.” This includes integrating **sustainable transportation**, waste reduction strategies, and green infrastructure into urban planning.

Health and Well-Being

- **Improved Healthcare Access:** Municipalities are focusing on improving access to **quality healthcare**, especially in rural and underserved areas, in alignment with SDG 3 (Good Health and Well-being). Many municipalities have launched community health programs, mental health initiatives, and COVID-19 recovery efforts.
- **COVID-19 Response and Recovery:** Post-pandemic recovery strategies have been central in the VLRs, with municipalities emphasizing health system strengthening, vaccination campaigns, and addressing pandemic-induced socio-economic impacts.



Education and Skills Development

- **Improving Education Access and Quality:** Municipalities are investing in education and vocational training programs that are aligned with SDG 4 (Quality Education), focusing on skills development for youth, especially in the context of the changing labor market and digital transformation.
- **Youth Empowerment:** Many municipalities are designing programs aimed at **youth empowerment** through education, employment, and skills development to create pathways to work and active citizenship.

Enhanced Stakeholder Engagement and Partnerships

- **Multi-Stakeholder Partnerships:** Municipalities highlight the importance of building **strong stakeholder relationships**, including civil society, the private sector, and international organizations, to accelerate SDG localization.
- **Community Participation:** There is a focus on ensuring that local communities are actively engaged in decision-making and planning processes, promoting **participatory governance** and transparency in local administration.

Accountability and Transparency

- **Strengthening Governance Structures:** Several municipalities are committed to strengthening their **governance frameworks**, ensuring **transparency, accountability, and integrity** in local governance through anti-corruption measures and the active promotion of **good governance practices**.
- **Citizen-Centered Service Delivery:** Municipalities are increasing their focus on **citizen-centered service delivery** with the use of technology to improve service access and efficiency, particularly in rural and underserved areas.

Data and Monitoring for SDG Localization

- **Monitoring SDG Progress:** Municipalities are developing **systems for monitoring SDG progress** at the local level, using data and evidence-based approaches to assess impact. The availability and accessibility of local data have been prioritized to ensure effective tracking of SDG implementation.
- **Feedback Mechanisms:** Municipalities are establishing **feedback mechanisms** that allow residents to voice concerns, track the impact of municipal programs, and ensure greater accountability in SDG localization efforts.

Future Commitments and SDG Acceleration
