ECOSOC Partnership Forum

The 2025 Partnership Forum of the Economic and Social Council (ECOSOC Partnership Forum), was held on 5 February 2025 at the United Nations Headquarters in New York under the theme, “Advancing sustainable, inclusive, science- and evidence-based solutions for the 2030 Agenda for Sustainable Development and its Sustainable Development Goals for leaving no one behind”.

The Forum placed a special emphasis on the Sustainable Development Goals (SDGs) that will be reviewed at the 2025 high-level political forum on sustainable development (HLPF), namely Goal 3 (Good Health and Well-being); Goal 5 (Gender Equality); Goal 8 (Decent Work and Economic Growth); Goal 14 (Life Below Water); and Goal 17 (Partnerships for the Goals).

This impact report aims to summarize the key activities carried out in the lead up to and during the 2025 ECOSOC Partnership Forum to deliver its new mandate in line with A/RES/75/290A.



BACKGROUND

“

The partnership forum of the Economic and Social Council will be convened for one day by early February, back-to-back with the coordination segment. The partnership forum will engage countries, the United Nations system, including international financial institutions, as well as international organizations, parliamentarians, local governments, non-governmental organizations, the private sector, civil society, scientists, academia, women, youth and other stakeholders. The partnership forum will be organized in consultation with stakeholders and allow interactive discussions among all stakeholders on the main theme of the Council and the high-level political forum on sustainable development. The partnership forum will be focused on the exchange of new ideas, expectations and priorities for the work ahead for the Council cycle and the high-level political forum held under the auspices of the Council. The partnership forum will also discuss forward-looking actions by countries and all relevant stakeholders as well as innovative partnerships that can mobilize commitments and actions to advance the 2030 Agenda.

INCLUSIVE APPROACH

As requested by the UN General Assembly, the 2025 ECOSOC Partnership Forum was organized in consultation with stakeholders and allowed interactive discussions among all stakeholders on the main theme of the Council and the high-level political forum on sustainable development.

- The President of ECOSOC established an informal **Multi-stakeholder Advisory Group** to provide guidance on the Forum's scope, format and programme.
- UN DESA conducted a **global online stakeholder consultation** to solicit views, experiences and proposals from stakeholders worldwide on how to strengthen partnerships and stakeholder engagements to accelerate the implementation of the 2030 Agenda.
- Four **SDG action segments** (on Goal 3, 5, 8, and 14) were organized in collaboration with relevant UN entities and recognized stakeholder networks, associations, major groups, or stakeholder constituencies with expertise in the specific SDGs in focus.

ECOSOC PRESIDENT'S MULTI-STAKEHOLDER ADVISORY GROUP 2025

As an informal consultative mechanism to help guide and support the organization of the Forum, an informal **Multi-Stakeholder Advisory Group**, composed of 23 experts, was set up by the President of ECOSOC to provide guidance and views on the scope, format and programme of the event.

On **25 November 2024**, Members of the Multi-Stakeholders Advisory Group attended a virtual **Expert Group Meeting (EGM)** to provide inputs to the Partnership Forum programme and share information about new research, analysis and tools that could support in leveraging partnerships on the SDGs under review at the 2025 HLPF and examples of partnerships that could be featured during the 2025 Partnership Forum.

On **14 February 2025**, a second and final virtual Expert Group Meeting, was held as an informal discussion to reflect on and gather key takeaways from the Forum. The meeting featured remarks from the President of ECOSOC, who highlighted the event's success in fostering engagement and participation.

GLOBAL ONLINE STAKEHOLDER CONSULTATION

The global online stakeholder consultation generated **331 responses from 83 countries or areas**, with majority responses from Non-Governmental Organizations (NGOs), followed by Education & Academic Entities, Business & Industry, Children and Youth, Science & Technological Community, among others.

A **summary report** has been prepared by UN DESA ahead of the 2025 ECOSOC Partnership Forum, presenting key messages and policy recommendations from stakeholders emerged from the global online consultation to inform the Partnership Forum.

Our country is directly related to the ocean and maritime activities in every way possible. Therefore, Chile is a lead pilot country and hosted a national workshop which gathered various experts, stakeholders, ministries, and governmental institutions. It allowed us to build technical teams and move from theory to concrete actions. The partnership also benefits and contributes from/to the current IMO negotiations by developing innovative solutions and proper governance.

Further implementation will require more funding, technology development, and capacity building. I believe this phase of the project is just the beginning of something bigger that should grow, considering that the challenges ahead are complex and need international cooperation.

- The Forum featured **four “SDG Action segments”** on SDGs 3,5,8 and 14 that are under in-depth review at the July 2025 HLPF, organized in collaboration by UN entities and stakeholders.
- **A multi-stakeholder panel** moderated by the ECOSOC President focused on strategies to enhance investments in partnerships and catalyze action for SDG 17.
- **43 interventions** were presented during the plenary, including **36 Member States, 1 GA observer and 6 stakeholders.**
- **19 side events** were held in connection with the Forum, including 5 held inside UN Headquarters and 14 held off-site or virtually. Member States, UN Entities, IGOS and NGOs in consultative status with ECOSOC attended the event.
- **505 stakeholders** requested Special Events Tickets to observe the proceedings.

PROGRAMME

The 2025 ECOSOC Partnership Forum was a one-day meeting chaired by the ECOSOC President. It featured:

- **Opening Session:** Opening remarks by the ECOSOC President and Mr. Guy Bernard Ryder, Under-Secretary-General for Policy at the Executive Office of the Secretary-General (EOSG).
- A **Plenary Session** where Member States and stakeholders shared priorities, experiences, and recommendations for advancing the SDGs.
- **Four SDG Action Segments** on Goals 3, 5, 8, and 14, showcasing innovative, partnership-based solutions to accelerate SDG progress.
- A **Multi-stakeholder panel - Investing in Partnerships: Catalyzing Action for SDG 17**, emphasizing strategic investments and partnership effectiveness.
- Nearly 20 **side events**, held at UNHQ and virtually, highlighting multi-stakeholder initiatives supporting the Forum's theme and SDGs under review.



Organized by UNEP, UNESCO-IOC, Scientific and Technological Community Major Group, Major Group for Children and Youth and Indigenous Peoples Major Group, the session addressed the growing threats of ocean warming, acidification, pollution, and biodiversity loss while emphasizing the urgent need for holistic policies, investment in ocean sciences, and inclusive governance.


