

# NATIONAL STATEMENT OF BRUNEI DARUSSALAM

# AT THE THIRD UNITED NATIONS OCEAN CONFERENCE 2025 (UNOC3)

9<sup>th</sup> to 13<sup>th</sup> June 2025 Nice, France

### Thank You Mr. President,

#### Your excellencies,

 Brunei Darussalam wishes to express its sincere appreciation to the United Nations and the co-hosts, France and Costa Rica, for convening this important conference. We are honored to join global partners to advance our shared goal of protecting our ocean—under the theme "Accelerating Action and Mobilizing All Actors to Conserve and Sustainably Use the Ocean."

- 2. As a small coastal nation, the ocean is central to our heritage, economy, and way of life. But like the rest of the world, we face the challenges of preserving marine resources amid increasing pressures from overfishing, climate change, marine pollution, and habitat degradation.
- Thus, it is crucial for us to protect our oceans through better stewardship of the sea and its resources, in line with the Sustainable Development Goal 14: Life Below Water.

### Your Excellencies,

- 4. In reaffirming our commitment to sustainable ocean governance, Brunei Darussalam have adopted an ecosystem-based policy aligned with the United Nations Convention on the Law of the Sea (UNCLOS) and the promotion of regional cooperation. Our efforts in strengthening ocean resilience include:
  - Designating over 20% of our fisheries management area (more than 1,200 sq km) as "No Take Zone" / Marine

**Protected Areas**, to prevent overfishing and safeguard marine biodiversity;

- ii. Since 2001, Brunei Darussalam have enforced a moratorium on new bottom trawling license;
- iii. Ban on shark fishing and trade of all shark products in effect since 2015, to protect the threatened marine species and preserve ecological balance;
- iv. Our efforts to combat Illegal,
  Unreported, and Unregulated fishing
  have been ongoing since 2011
  through the active enforcement of

National Plan of Action. In a significant step forward, Brunei Darussalam has mandated the use of Automatic Identification System on commercial fishing vessels to enhance tracking and introduced an Electronic Catch Documentation Scheme to ensure full traceability;

 v. Seagrass is vital to the resilience and productivity of marine environment; hence, Brunei Darussalam is also committed not only to the conservation but also actively propagate our seagrasses, with special focus on the vulnerable species;

# vi. Between 2020 and 2023, over **1,400** artificial reefs were deployed; and

vii. We are committed to **deploy additional 1,000 artificial reefs by 2029**, demonstrating our dedication to marine conservation and environmental sustainability. As we continue to expand this initiative, we welcome interested parties to join us in this effort.

### Your Excellencies,

 Science and innovation are central to our strategy for sustainable ocean governance. We are conducting national fish stock assessments in collaboration with the Southeast Asian Fisheries Development Center and developing a Fisheries Stock Database to enable informed and evidence-based decisions for sustainable fisheries management.

- 6. We are leveraging on artificial intelligence to enhance coral reef monitoring, which allow more accurate assessments of reef health and strengthens our capacity to respond to climate change and ocean acidification.
- 7. Plastic pollution continues to pose a serious threat to marine ecosystems. The

"No Plastic Bag Everyday" campaign and community-led coastal clean-ups reflect our commitment to reducing plastic waste and alleviate negative impact to the ocean.

8. Our policies are also aligned with the Kunming-Montreal Global Biodiversity Framework. We have recently updated the National Biodiversity Policy and Strategic Plan of Action 2024–2030, which sets goals for sustainable resource management, equitable benefit-sharing, and enhanced public awareness.

## Your Excellencies,

This year, we are proud to host the 9. International Forest to Reef Expedition and Conference, which gathers experts to strengthen cooperation in managing land, coastal, and marine ecosystems. Looking ahead, I am pleased to announce that we will hosting the International be Conference on Oceans in June 2026. We welcome global experts to join us and collaborate in advancing marine research and promote sustainable ocean use.

### Your Excellencies,

- 10. The ocean's vast, interconnected ecosystems and biodiversity demands for united and collective action to address common threats and advance our goal to conserve and sustainably use the oceans.
- 11. Brunei Darussalam calls for stronger international cooperation, technical support, and funding—particularly through strategic collaboration with organizations such as the UN and others. These are vital for building national capacity, driving innovation, and enabling

small coastal nations like Brunei Darussalam to take bold, science-driven actions to protect ocean resources and ecosystems.

12. Lastly, Brunei Darussalam echoes the conference's theme and is firmly committed to accelerate efforts and mobilize resources to deliver lasting, positive change for our oceans. Let us continue to work together to secure a resilient, inclusive, and sustainable future for our oceans.
