# Background

As the Voluntary National Reviews (VNRs) mark their 10-year anniversary in 2025, this VNR Lab offers a space to reflect on how inclusive approaches to SDG reporting have evolved and where they can take us in the final stretch toward 2030. The session will bring together Member States and stakeholders to share lessons learned, highlight effective collaboration throughout the VNR process, and explore how multi-stakeholder engagement can enhance accountability and accelerate progress on the Sustainable Development Goals amid ongoing global challenges.

#### **Proposed discussion questions:**

- How can countries effectively engage a diverse range of stakeholders, including marginalized communities, in the VNR process to ensure comprehensive and inclusive SDG reporting?
- What are the most significant challenges faced by Member States in integrating multi-stakeholder feedback into their VNRs, and what best practices can be adopted to overcome these challenges?
- How did your organization engage in the VNR processes? How have you seen the engagement of civil society in the process evolve over time?
- How can the VNRs and the preparatory process be more accessible to stakeholders? What could governments do to better include stakeholders in their VNR process?
- In what ways can civil society organizations contribute to enhancing the transparency and accountability of the VNR process?
- Looking back over the past decade of VNRs, how have countries that have submitted multiple reports seen progress toward their SDG commitments? What lessons can be drawn from their experiences?
- For countries that have completed more than one VNR, have you observed a shift in how stakeholders are engaged? Has stakeholder inclusion become more meaningful or systematic over time?
