

## 2025 Questionnaire for the UN System SDG Implementation Database

### *Transformative, equitable, innovative and coordinated actions for the 2030 Agenda and its SDGs for a sustainable future for all*

The online [UN System SDG Implementation Database](#) hosted by the Department of Economic and Social Affairs (DESA) is a repository of actions, initiatives and plans by UN system entities on their implementation of the 2030 Agenda for Sustainable Development and the Sustainable Development Goals (SDGs). Updated annually through a questionnaire, the database currently contains input from more than 50 UN system entities, including decisions taken by intergovernmental bodies to guide the implementation of the 2030 Agenda, as well as specific actions and initiatives, including their contributions to the UN high-level political forum on sustainable development (HLPF).

The 2025 edition of the questionnaire is designed to inform the 2026 session of the Economic and Social Council (ECOSOC) and the 2026 high-level political forum on sustainable development and therefore is aligned with its annual theme “*Transformative, equitable, innovative and coordinated actions for the 2030 Agenda and its SDGs for a sustainable future for all*” ([A/RES/78/285](#)). The information collected through the questionnaire is expected to inform the preparations of relevant intergovernmental meetings, such as the ECOSOC Partnership Forum (27 January 2026), the Coordination Segment (28-29 January 2026), the HLPF under the auspices of ECOSOC (6-10 July & 13-16 July 2026), among others.
