Energy is central to the achievement of both the 2030 Agenda for Sustainable Development and the Paris Agreement on Climate Change. The High-Level Political Forum in 2018 will serve as a first critical milestone to review progress of SDG7 on energy toward 2030. To support this process and prepare substantive input, DESA, ESCAP and the Government of Thailand jointly convened the *Global SDG7 Conference* in Bangkok in February 2018. A set of 27 *Policy Briefs* on SDG7 and its interlinkages with other SDGs have been compiled by the multi-stakeholder SDG7 Technical Advisory Group, composed of experts from governments, UN organisations, international organisations and other stakeholders convened by DESA.
