

Malcolm Johnson, Deputy Secretary-General, ITU

Malcolm Johnson was elected Deputy Secretary-General of the ITU on 24 October 2014 and started his mandate on 1 January 2015.

From 2007 to 2014 he served as Director of ITU's Telecommunication Standardization Bureau where he spearheaded activities in cybersecurity, climate change and accessibility, considerably increasing the involvement of developing countries and academia in ITU's standards activities.

Between 2003 and 2006, Mr Johnson was International Coordinator at the United Kingdom's Office of Communications (Ofcom), where he had lead responsibility for the United Kingdom in ITU and in CEPT. From 1992 to 2003, he was Director of the United Kingdom's Radiocommunications Agency and between 1988 and 1992, he worked in the European Commission's Telecommunication Regulations Division, where he represented the Commission in the Council of the European Union, EU Parliament, CEPT and ITU.

H.E Mr. Fodé Seck, Ambassador Permanent Representative of Senegal to the United Nations

Since February 2014, Mr. Seck has served as his country's Ambassador to the United Nations Office and other international organizations in Geneva. From November 2007 to September 2010, he was Senegal's Ambassador to Brazil.

From December 2006 to September 2007, he was Charge d'affaires at the Senegalese Embassy in Riyadh, Saudi Arabia, having served previously as General Secretary of the Government in Charge.

From March 2002 to December 20006, he was Chief Technical Adviser to the Minister of State and Foreign Affairs, after serving in several other posts in the Ministry since 1986.

From 1981 to 1986, he was a First Counsellor at the Senegalese Embassy in Nigeria, following a stint from 1978 to 1981 in the same capacity at his country's embassy in the former Soviet Union.

Mr. Seck has a Master of Arts degree in English from the University Cheikh Anta Diop in Dakar.

Born on 1 September 1950, he is married and has six children.

Jim Gowen, Chairman, GeSI

Jim Gowen holds the complementary roles of vice president of Supply Chain Operations and Chief Sustainability Officer for Verizon. As Verizon's Chief Sustainability Officer, Gowen is responsible for setting the direction of the company's sustainable growth strategies and for reducing its carbon footprint. He also oversees initiatives being implemented across Verizon including fuel and energy reduction, paper suppression, waste reduction and recycling, and management of end-of-life-cycle material recovery. In his supply chain role, Gowen leads centralized operations and the global customer premises equipment program with responsibility for more than \$2.5 billion in annual through-put and half a billion dollars in annual inventory. He oversees Verizon's regional distribution centers, purchasing and materials management, investment recovery, international supply chain and centralized fleet operations. Gowen earned his master's degree in business administration from Long Island University and his bachelor's degree from Manhattanville College.

Luis Neves is MD of the Global e-Sustainability Initiative (GeSI), and served until recently as Climate Change and Sustainability Officer, Executive Vice President at Deutsche Telekom Group. With over thirty years of experience at national and international level in the field of telecommunications and Information Society, Mr Neves has played a fundamental role in promoting the role of ICT in relation to climate change. He was the driving force and chairman of the steering committee of the acclaimed GeSI SMART series of reports. He held positions and participated in a range of international projects and initiatives including GeSI, the United Nations Global Compact Group and Steering Committee of the United Nations Caring for Climate Initiative.
