From 2010 to 2018 he served as Director of the Financing for Development Office of DESA. Prior to this Mr. Trepelkov worked in DESA Macro- and Micro-economic and Social Policy Analysis and Public Administration and Finance. Prior to joining the UN Secretariat in 1989, Mr. Trepelkov served in the Russian diplomatic service.

Mr. Amson Sibanda is Chief of NSCBB for Sustainable Development Goals, DESA. He has over 15 years of progressively responsible experience in a broad range of sustainable development issues at the global, regional and national levels, including the various intergovernmental processes that underpin this work.
