



Sustainable and just economies: Lessons learned from the COVID-19 Crisis and enabling factors for the SDGs

The COVID-19 crisis and economic impact of the “Great Lockdown” has both highlighted the urgency of Agenda 2030 and threatened to rollback progress made since 2015.

Ensuring that the recovery points towards a development model that delivers a triple bottom-line of prosperity, planet and people in light of the global pandemic requires coordinated and well-integrated policies to maximise opportunities for more and better jobs, social inclusion, and social justice. Consultation among the main stakeholders of the world of work is instrumental to achieve consensus and respect for labour rights and ensure that no one is left behind during the transition towards sustainable and just economies.

Action is needed to support the Agenda 2030 vision of an equal and sustainable world, as well as renewed commitment from government and business to ensure transparency, accountability, and clarity of decision-making as well as align efforts towards a just, people-centred recovery during the Decade of Action.

Objectives

The workshop brings together information and experiences from different schemes of work on the issue of sustainable economies. These diverse experiences will allow the participants to have a broader understanding into various perspectives and issues under this heading, as well as providing them with tools to enable and support their critical perspectives in these issues. In addition, the workshop foresees the presentation of tools that promote collaboration among different sectors that can help incentivize and catalyze the achievement of SDGs and a quick transition to sustainable and just economies.

Moustapha Kamal Gueye, ILO



Dr Moustapha Kamal Gueye is Coordinator, Green Jobs Programme, at the [International Labour Organization \(ILO\)](#), working to promote positive employment outcomes of policies on climate change, green economy and sustainable development. Previously, he served as Head, Green Economy Advisory Services at the [United Nations Environment Programme \(UNEP\)](#) and as a Senior Programme Manager at the International Centre for Trade and Sustainable Development in Geneva. Earlier, he spent twelve years across Asia working at the [Institute for Global Environmental Strategies \(IGES\)](#) in Japan. He currently serves as a member of the Advisory Committee of the [Green Economy Coalition](#) and the Advisory Committee of [GEO for Business](#). Kamal holds a Ph.D. from Nagoya University, Japan; DEA and LL.M from Dakar University; and Executive Certificates from the World Bank Institute; Columbia University; Foundation for Advanced Studies on International Development, Japan; and Integrated Research and Action for Development, India. He speaks Wolof, French, English, and Japanese.

Isabell Kempf, UNRISD



Isabell Kempf leads the UNRISD Bonn Programme on Integrating Knowledge and Capacity Development for the SDGs. Prior to joining UNRISD, Isabell was the co-Director of the UNDP-UNEP Poverty-Environment Initiative based at UNEP in Nairobi. She has 26 years of experience working with the UN, including UNESCO, the Economic Commission for Latin American and the Caribbean, and the Office of the High Commissioner for Human Rights. She also has post-graduate degrees in Gender and Public Policy as well as Social Communication from universities in Chile.

Between 2016 and 2018 she worked as labour specialist for the Special Representative of the Secretary-General for International Migration to support the negotiation process that had led to the adoption of a Global Compact for Migration. She has also worked for 2 years a CSR Manager for JBC, the biggest Belgian fashion retail company.

Dan Neale, World Benchmarking Alliance



Dan Neale leads the social transformation within the WBA, responsible for establishing the framework to assess the 2,000 keystone actors on core social aspects. Previously, Dan led the Corporate Human Rights Benchmark (CHRB), doubling the number of companies assessed and setting up UNGP Snapshot assessments, supporting the movement for mandatory human rights due diligence. Before CHRB, he spent five years working with extractives and renewable companies on social risk and impact management in the UK, Middle East and sub-Saharan Africa. Dan spent his twenties with the British military, with several years spent working in stabilisation, influence, community engagement and training roles.

Elena Botvina, UNCTAD



Elena Botvina is an Economic Affairs Officer at the Division of Investment & Enterprise of UNCTAD, working on harmonization and comparability of sustainability reporting in attainment of 2030 Agenda for Sustainable Development with a view to facilitate sustainable investment and inclusive growth.
