Group 1 joint statement on: People, Planet and Partnerships

Co-facilitators, Member States, fellow colleagues,

Thank you for giving us the opportunity to make this statement. Alongside you, we have been working on the sustainable development agenda for the last few years and are now so close to the finish line of what Ambassador Kamau described this morning as “a fantastic race”.

We are required to make our oral contribution today a mere two minute sprint, which is nearly impossible given the marathon that we have been on. We will be circulating longer written documents every day to all member states, including specific language recommendations, and hope that you will take the time to reflect on it.

Many of us question the structure of “The Five P’s”. We need a Preamble that fulfils the vision of an integrated, universal, and interdependent agenda bringing together the three dimensions of sustainable development. The Preamble in its current form risks reinforcing silos.

For example can we really separate the achievement of people from peace? Nature and the services that our planet provides are the foundation for Prosperity and People’s quality of life. Partnerships cannot exist without people, and will not be inclusive, participatory and transparent without real structural reforms. Without decisive action to ensure gender equality, we cannot achieve a prosperous and peaceful planet for posterity.

None of these P’s can stand alone. The opening of the Preamble must illustrate the interconnectivity between these principles and our longer statement includes a text recommendation for this. Otherwise we will continue to work in silos and to be siloed.

We must further break these silos through genuine participation. This is essential to every aspect of the agenda, it must be considered an overarching principle. States must ensure genuine participation through ensuring that there are no physical, legal, or institutional barriers to participation, including access to information and ICTs. Without these concrete steps, many including children and persons with disabilities, will have no voice. If this participation is not guaranteed, this will not be an agenda of the people, by the people and for the people.

We have a moment today, tomorrow, for the next two weeks to actually change the world in which we live and to – once for all – ensure that no one is left behind. Let us not lose sight of this goal.

Preamble

This Agenda is a plan of action for people, planet and prosperity that also seeks to strengthen universal peace in larger freedom. All countries acting in collaborative partnership will implement the plan. The 17 Sustainable Development Goals and 169 targets which we are announcing demonstrate the scale and ambition of the new Agenda. They will stimulate action over the next fifteen years in the following areas of critical importance for humanity and the planet:

This Agenda is a plan of action for people, planet and prosperity that also seeks to strengthen universal peace **and protect, promote and fulfill human rights for all** in larger freedom. All countries acting in collaborative partnership, will implement the plan. We are resolved to free ~~the human race~~ **all peoples** from the tyranny of poverty, **inequalities, fear, violence** and want and to heal and secure our planet for present and future generations. **by respecting our planetary boundaries** **We recognize that these objectives are inextricably linked.** We are determined to take the bold and transformative steps needed to shift the world on to a sustainable **and resilient path.** As we embark on this collective journey, we pledge that no one will be left behind. **It is an agenda of the people, by and with the people – and this, we believe, will ensure its success.”**

The 17 Sustainable Development Goals and 169 targets which we are announcing demonstrate the scale and ambition of the new **universal** Agenda. **They are integrated and indivisible and** will stimulate action **by all countries and stakeholders, with the meaningful participation of all people,** over the next fifteen years in the following areas of critical

The proposals focus on better signaling the interconnections in the Agenda. The text relating to the global partnership remains somewhat abstract and lacks concrete detail.

The Preamble must reinforce the interdependent and holistic aspect of the agenda to avoid for the proposed 5 P's to be perceived as silos. The Preamble must include references to the interlinkages, integration and universality (already affirmed elsewhere in the text).

The Preamble must bring the notion of participation from the very beginning.

It is important to qualify participation as “meaningful”. The reference to persons with disabilities brings the attention to the barriers to participation frequently faced by them. Persons with disabilities most of the time require additional mechanism/processes put in place in order to ensure their participation (such as ramps, sign language interpretation etc.) Therefore it is necessary to explicitly reference them in the preamble para. In addition</p>

		<p>persons with disabilities are not a group, but compose a significant part of the society, all together there are 1 billion persons with disabilities.</p> <p>There is currently little reference to “barriers” to participation in the text. To be meaningful, participation must be “enabled” or the most marginalized will not be reached.</p> <p>We welcome the mention of “achieve gender equality” and propose some changes that highlights the centrality of a rights based approach to this Agenda.</p>
<p>Planet</p> <p>We must respect and safeguard our common home. We want to protect the planet so that it can support the needs of present and future generations. We will conserve and sustainably use our oceans and seas; fight climate change; protect and restore ecosystems; combat desertification, land degradation and biodiversity loss; promote safe and inclusive cities and human settlements; and promote disaster risk reduction.</p>	<p>We must respect and safeguard our common home.
