# SDG targets requiring SCP action and policies

## 31 targets

within the 6 goals up for review at HLPF 2018 are **contingent upon SCP**

SCP focused partnerships, such as those in the six 10YFP programmes, can support their effective implementation

There are important SCP related targets in other goals, notably 2, 3, 4, 8, 9 and 14

**SCP National Action Plans are cross-sectoral, emphasize resource efficiency and enhance coherence and inter-ministerial cooperation**

**SCP National Action Plans also engage the private sector and consumers, are an indicator for SDG target 12.1, and exist in around 35 countries**


