### MAIN GUIDING PRINCIPLES

- Integrate economic, environmental and social
- Base on long-term vision
- Ensure broad participation
- Promote country ownership
- Develop domestic capacity/enabling environment
- Focus on outcomes and implementation



### **GOOD GOVERNANCE**

- National or federal-level strategy
- Horizontal across departments and agencies
- High-level leadership and political commitment
- Fully involves stakeholders
- Linked to budget processes
- Linked to sub-national levels

## OECD BEST PRACTICES

- Policy integration
- Intergenerational timeframe
- Analysis and assessments
- Indicators and targets
- Co-ordination and institutions
- Local and regional governance
- Stakeholder participation
- Monitoring and evaluation



#### REVISED BEST PRACTICES

- DIFFER BY GOVERNANCE STRUCTURE
- ROLE OF SD COMMUNICATION & MARKETING
- ROLE OF SD LEGISLATION & CONSTITUTION
- NEED FOR SD MINISTRY OR HIGH-LEVEL UNIT
- NEED FOR BUDGET CARROTS and STICKS
- SD COUNCILS and STAKEHOLDERS
- GOVERNMENT PROCESSES, MACHINERY



### GOOD REVIEW PRACTICES

- Base strategy on indicators and targets
- Have regular internal reviews
- Conduct independent audits
- Promote parliamentary reviews
- Link to budgetary processes
- Organise or volunteer for peer reviews



### STRATEGY INTEGRATION

- Have agreed Poverty Reduction Strategies (PRS)
- Link to National Sustainable
   Development Strategies (NSDS)
- Integrate Millennium Development Goal (MDG) targets
- Evolve from PRS to NSDS



# UN REPORTING SYSTEM (once during 2-year UNCSD cycle)

- National Focal Point for Sustainable Development
- 2) Status of National Sustainable Development Strategies
- 3) Concrete actions and case studies addressing current themes of UNCSD – climate change, air pollution, energy, industry



### **UN REPORTING QUESTIONS**

- Does your country have an NSDS, PRS, national development plan, national environmental action plan, or other?
- If your country has a PRS but not an NSDS, does the PRS address environmental, economic and social aspects of development?
- If your country has both PRS and NSDS, are they linked?
- Does your PRS or NSDS target the MDG?

#### EU PEER REVIEW INITIATIVE

- Developed Guidebook for Peer Reviews
- Issued call for proposals/countries
- EU provides matching funds up to €100 000
- Conditions:
- Secure political support from Ministers
- Use guidebook methodology
- Use a panel of reviewers (2 EU members, 1-2 non-EU members, EC as observer)
- Look at links between national and EU strategies

## OECD PEER REVIEW PROPOSALS

From 2006 Annual Report on Sustainable Development Work in the OECD:

- Economic reviews examine topics (health, housing) from sustainable development perspective
- DAC reviews review donor assistance programmes from sustainable development perspective
